3. Explain how the proposed project or program is considered transformational and how it will effect the disproportionately affected counties in the next ten (10) years.

Camp Longleaf will have a transformational effect on Walton County by creating a unique asset in the region and building upon the quality of educational programs for local students.

The Camp Longleaf facility and programs will draw eco-tourism visitors and provide economic and educational benefits to our area, including the creation of new jobs and the continued enhancement of science education for our local students in Walton, Bay, Washington, Holmes, and Okaloosa Counties.

4. Describe data or information available to demonstrate the viability of the proposed project or program.

Since the Biophilia Center and Nokuse Plantation's inception, people from all over the country have travelled to Walton County to visit our facilities and campus. We have already hosted many student groups from out of town, including students from Birmingham Southern College, Community Collaborations International, and Bob Jones High School. Currently, visitors stay in a nearby hotel at night while they experience the Biophilia Center programs and curriculum during the day.

Construction of the Camp Longleaf facility will allow the Center to expand its programming to meet the market demand for an overnight environmental education camp facility in Walton County.

Announcement of our construction plans has been met with great interest, and the Biophilia Center staff has already begun booking Naturalist Outdoors student visits for Fall of 2018.

At this writing, we already have two groups scheduled, totaling 70 students and 7 chaperones.

The viability of the Camp Longleaf project is demonstrated through conservative financial projections in the pro forma operating budget attached.

5. Describe how the impacts to the disproportionately affected counties will be measured long term.

Impacts to the disproportionately affected counties will be measured long-term in multiple ways:

First, impacts will be measured through the increase in net-new visitors to the local area (as demonstrated in the projected new visitor calculation attached). We estimate conservatively that Camp Longleaf will host over 1,500 net-new visitors to the area by its fifth year in operations, a figure that will continue to grow over time to over 2,100 visitors annually.

Second, impacts will be measured through the increase in net-new revenue to the local area (as demonstrated in the pro forma operating budget attached). We estimate conservatively that Camp Longleaf will generate gross revenues of over \$580,000 per year by its fifth year in operations, a figure that will continue to grow over time to over \$1,000,000 annually.

All revenue generated through Camp Longleaf is net-new to the area, and almost all expenses are local. So, money will be brought in from out-of-town and spent locally, creating a money-multiplier effect and causing even greater economic impact to the area.

Net income generated from Camp Longleaf programs will be spent furthering the Biophilia Center's mission of providing FREE environmental education to Walton, Okaloosa, Bay, Holmes, and Washington County students with a concentration in STEM subjects.

Third, impacts will be measured by the net-new jobs created by the program, including six full-time positions, two part-time positions, and ten to twenty seasonal summer positions.

Through research and conservative estimating, we have determined that Camp Longleaf facility and programs will generate gross revenues of over \$580,000 per year by its fifth year in operations, a figure that will continue to grow over time to over \$1,000,000 annually. The project is projected to generate positive net income in its second year of operations.

Net income generated from Camp Longleaf programs will be spent furthering the Biophilia Center's mission of providing FREE environmental education to Walton, Okaloosa, Bay, Holmes, and Washington County students with a concentration in STEM subjects.

7. Describe how the deliverables for the proposed project or program will be measured.

Camp Longleaf deliverables include net-new visitors to the area, net-new revenues, net-new jobs, and continued FREE science education provided to local students by the Biophilia Center.

The first project deliverable is in the form of net-new visitors (conservative estimates are demonstrated in the projected new visitor calculation attached). Net-new visitors will be measured by keeping track of the number of attendees of Camp Longleaf summer camps, Naturalists Outdoors programs, and other programs.


The second project deliverable is in the form of net-new revenues (conservative estimates are demonstrated in the pro forma operating budget attached). Net-new revenues will be measured by keeping track of the dollars generated by Camp Longleaf summer camps, Naturalists Outdoors programs, and other programs.

The third project deliverable is in the form of net-new jobs. The camp director and assistant director have already been hired by the Biophilia Center. They are already planning programs and curriculum for Camp Longleaf and providing input on the facility design and construction. Once construction is complete, a full-time cook will be hired. A full-time educator and two nurses (one night-shift and one day-shift) will be hired in the third year of operations (sooner if demand requires). A part-time food prep person and a part-time maintenance person will be hired in the fourth year of operations (sooner if demand requires). Ten to twenty (depending on demand) seasonal summer workers will be hired to assist with summer camp programming every year.

Net income generated through Camp Longleaf programs will be used to enhance the quality of education for our most treasured regional assets – our children. Camp Longleaf net income will be spent furthering the Biophilia Center's mission of providing FREE

environmental education to Walton, Okaloosa, Bay, Holmes, and Washington County students with a concentration in STEM subjects. So, a fourth deliverable would be the local students provided with free environmental education each year as a result of the Biophilia Center's continued operations.

The Biophilia Center broke ground on the construction of the Camp Longleaf facility in December 2017. Sitework construction is currently underway. Phase I construction of five cabins, a boardwalk, and a common area is expected to be complete by September 2018, allowing for the use of Camp Longleaf's facility for Alaqua guests, Westonwood trainees, and Natural Outdoors program students through the Fall, Winter, and Spring seasons of 2018-2019, followed by our first summer camp sessions beginning in May of 2019.

Triumph funding of \$600,000 will be the "last dollars in," allowing Phase II of the project to be constructed: five additional cabins, infirmary, and snack shack. If Triumph money is awarded, we will engage our General Contractor on constructing Phase II as soon as possible,

The project broke ground in December 2017 and sitework construction is currently underway. Phase I construction of five cabins, a boardwalk, and a common area is expected to be complete by September 2018. Payments will be made on a monthly basis to the General Contractor, Horizon Design Build, a local Walton County builder, based on the work that has been completed onsite. Salaries for the two employees that have already been hired are being paid on a monthly basis.

Triumph funding of \$600,000 will be the "last dollars in," allowing Phase II of the project to be constructed: five additional cabins, infirmary, and snack shack. If Triumph money is awarded, we will engage Horizon on constructing Phase II as soon as possible, with payments being made on a monthly basis based on the work that has been completed onsite.

Grant Proposal The E.O. Wilson Biophilia Center (Nokuse Education, Inc. – 501(c)(3))

The E.O. Wilson Biophilia Center, located on Highway 20 in Freeport, FL, is seeking a grant in the amount of \$600,000 from Triumph Gulf Coast for a portion of the construction and first-year operating costs of Camp Longleaf, the first and only overnight environmental education camp facility in Walton County.

The objectives of Camp Longleaf are to attract eco-tourism visitors to Walton County, to provide an additional revenue source for the Biophilia Center, and to further the nonprofit's mission of providing environmental education with a concentration on STEM (Science, Technology, Engineering, and Math) subjects. Camp Longleaf will be able to accommodate over 2,000 visitors on an annual basis when fully utilized and will create six full-time jobs, two part-time jobs, and ten to twenty seasonal summer jobs, as well as fifteen to twenty jobs during the construction phase of the project.

The Walton County Board of County Commissioners and the Walton County TRIUMPH Committee awarded this proposal an "A" rating during the pre-application review process on November 1st.

Background

The Biophilia Center is in its ninth year of providing FREE environmental education to Walton, Okaloosa, Bay, Holmes, and Washington County students with a concentration in STEM subjects. The surrounding five local school districts consider the Biophilia Center to be an extension of their classroom, as we are their science education project-based learning facility – the place where schooling becomes applicable. Each year, the Biophilia Center educates over 6,000 students in a five-county area and averages more than 100 students every school day.

Students who visit the Biophilia Center learn about the natural environment through interpretive exhibits as well as an extensive trail system through natural areas on Nokuse Plantation. The Biophilia Center's curriculum coincides with Florida's education standards. While promoting STEM subjects, students are provided opportunities for inquiry, investigation and innovation by gaining a better understanding and knowledge of their natural surroundings.

Program Description

Camp Longleaf will be a destination point to draw visitors through eco-tourism and environmental education opportunities. Planned programming includes summer camps, collegiate and high-school internships, weekend team-building retreats for businesses, facility rentals, and the Naturalist Outdoors

program, which offers K-12 schools from areas outside of the five surrounding counties the opportunity to participate in the Biophilia Center's programs during the school year.

The Camp Longleaf facility will be composed of ten 400-square foot cabins and a 3,500-square foot common area with restrooms and a kitchen. Each cabin will be joined by a raised boardwalk with a central fire pit feature. Each cabin will house ten campers each, with a total of 100 potential campers participating during each weeklong summer camp session. When fully utilized, Camp Longleaf will be able to accommodate over 2,000 visitors annually.

The Biophilia Center has created over 700 pages of science curriculum for local school districts, which will be adapted for use in Camp Longleaf's weeklong summer camp programs. Visitors will gain valuable educational experience through utilization of the Biophilia Center's existing campus, including the museum exhibits, trails, gardens, gopher tortoise enclosures, birds of prey, and bobcats. The Biophilia Center has already hired a Camp Director and an Assistant Director for Camp Longleaf, and plans to hire four more full-time positions, two part-time positions, and ten to twenty seasonal positions each summer once the facility has been constructed. An estimated fifteen to twenty positions will be required for the construction phase of the project.

Camp Longleaf has partnered with Westonwood Ranch and Alaqua Animal Refuge to offer Walton County a strong basis of local nonprofits that are making this county a powerhouse of charitable growth and economic prosperity. Alaqua Animal Refuge plans to utilize the Camp Longleaf facility for their visitors and provide Camp Longleaf campers instruction during a half-day field trip at the animal refuge during each camp session. Westonwood Ranch will be using Camp Longleaf as a training location for their clients to gain real-life job experience by performing grounds maintenance and janitorial duties. The E.O. Wilson Biophilia Center is continuously seeking further opportunities for synergistic partnerships with other nonprofits and local businesses.

The Camp Longleaf facility will be located in Freeport, Florida on parcel number 20-1S-18-14000-012-0000 just west of the Biophilia Center on Highway 20. The 1.66 acre development has already been approved through the Walton County Planning Department with the issuance of Development Order No. 17-00100129.

Budget

Total estimated cost for the construction of the facility and first year operations is \$1,200,000, as itemized in the chart on the right. The project already has financial backing from two separate sources. The Dugas Family Foundation has provided \$300,000 for the project, of which \$40,000 has already been paid out for the engineering, surveying, and architectural work. The Stella Davis Trust has also provided \$300,000 for the project.

Timeline

The Biophilia Center broke ground on the construction of the Camp Longleaf facility in December 2017. Construction is expected to be completed by September 2018, allowing for Camp Longleaf facility use for Alaqua guests, Westonwood trainees, and Natural Outdoors program students through the Fall, Winter, and Spring seasons of 2018-2019, followed by our first summer camp sessions beginning in May of 2019. One group from Birmingham and one group from Atlanta are already scheduled for Fall visits, totaling seventy students and seven chaperones.

Goals and Objectives

As the first and only overnight environmental education camp facility in Walton County, a primary objective of Camp Longleaf is to attract eco-tourists to our area through the unique environmental opportunities afforded by the E.O. Wilson Biophilia Center and Nokuse Plantation Nature Preserve.

Another objective of the Camp Longleaf facility and program is to generate revenue to fund existing and new environmental education programs, including the creation of local jobs. The income generated by Camp Longleaf will contribute to the self-sufficiency of the Biophilia Center. As a 501(c)(3), the Biophilia Center relies on donations, memberships, grants, event income, and sponsorships for its survival. Camp Longleaf will add a source of earned revenue through summer camp programs, facility rentals, etc.

Finally, Camp Longleaf provides another way for the Biophilia Center to further its mission of providing environmental education with a concentration on STEM subjects. Our goal is to encourage each new generation to be good stewards of our lands and waters and promote future careers in science, education, and environmental studies.

Conclusion

Camp Longleaf is a project that meets many of the Triumph Gulf Coast priorities for economic recovery, diversification, and enhancement, including preparing students for careers in education and STEM disciplines, benefitting the environment, creating net-new jobs and net-new revenue, aligning with other similar programs across the regions for greater impact, and leveraging funding from other private entity sources. Camp Longleaf will help to achieve the goals found on the Walton County seal of *Pride, Preservation and Conservation*. Camp Longleaf will have a transformational effect on Walton County by creating a unique asset in the region. The Camp Longleaf facility and programs will draw eco-tourism visitors and provide economic and educational benefits to our area, including the creation of new jobs and the continued enhancement of science education for our most treasured regional asset – our local students.

The Camp Longleaf project already has significant financial backing from local donors and partnerships with respected local nonprofits. The E.O. Wilson Biophilia Center has successfully hosted summer day camps and Naturalist Outdoors programs in the past. Funding for the Camp Longleaf project will allow the Biophilia Center to expand its outreach and mission by drawing eco-tourism visitors from across the Southeast to Walton County.

Let this letter serve as formal notification of the activities and directives taken by the Walton County Board of County Commissioners (BCC) to comply with 288.8017, Fla. Stat.:

"Each Board of County Commissioners shall solicit proposed projects and programs from other elected local governing boards within the County as shall provide Triumph Gulf Coast Inc. with a list of proposed projects and programs located within the County."

After holding numerous public meetings throughout the County to educate and encourage citizens and business owners regarding the opportunities presented by Triumph Gulf Coast, 36 prescreen applications were submitted to the County for possible endorsement. The Walton County BCC appointed a committee, known as the Local Triumph Committee, of eleven individuals to evaluate and score these submittals. This committee is comprised of five nonaffiliated community stakeholders along with six members affiliated with local governmental agencies. Details regarding The Local Triumph Committee can be found on the Walton County website.

The initial meeting of the committee was held on November 1, 2017 to review and score the 36 submitted projects, which were to be submitted to the County by 5PM October 30. At this meeting, one project, Destin Fisherman's Co-op, was approved to be considered and scored by the committee even though it missed the submittal deadline. The committee was instructed to answer three questions about each project; 1) does the project meet statutory requirements for eligible uses 2) does the project meet statutory priorities and 3) is the project transformational. It was explained to the committee that the first two criteria were somewhat objective in nature and that the concept of "transformational" was quite subjective. Given the subjective nature of the final question each member was encouraged to use their creative mind to determine whether a project was transformational or not. Committee members were to vote either yes or no on each of the three scoring questions for every project.

Each proposer was permitted to address the committee for three minutes to present their project. Those projects with no one to speak to the committee were read into the record and presented by county staff. After every presentation, each committee member scored the project by selecting yes or no on the above mentioned criteria. Upon all projects being presented and scoring complete, the Clerk of Count collected the scoring forms and reported the results back to county staff. Those projects receiving three yes votes got an A, those receiving two yes votes got a B, those receiving one yes vote a C and those not receiving any yes votes scored a D.

On November 7, 2017 the Walton County BCC was presented results of the scoring process and voted that those projects which received an A or B score would be endorsed for contemplation by the Triumph Gulf Coast Board of Directors as projects worthy of further consideration.

Please find attached, a complete list of submitted projects and the committee's score for each project. Those projects with scores of A and B are those endorsed by the Walton County Board of County Commissioners.
