Company overview paragraph

The company is the world's leading multi-technology tier 1 aerospace supplier. As a global company serving the world's leading aircraft manufacturers, the company develops, builds and supplies an extensive range of advanced aerospace systems, components and technologies— for use in aircraft ranging from helicopters and business jets to the most used single aisle aircraft and the largest passenger planes in the world. Lightweight composites, additive manufacturing, innovative engine systems and smart transparencies help to reduce emissions and weight on the aircraft and enhance passenger comfort. The company is market leading in aerostructures, engine systems, transparencies and wiring systems and operates in 14 countries at 51 manufacturing locations employing approximately 17,000 people. Every day over 100,000 flights take off around the world with the company's products helping to make them fly!

Existing Panama City facility

The company is already committed to the Bay County region and has established a manufacturing facility in Panama City, Florida. This facility, which is leased from St. Joe Company (10 year lease, with 2 five year options), occupies approximately 138,000 square feet and is on track to employ 170 full time equivalent jobs at an average wage of \$63,156 by 2020 and with \$55M of capital investment. The facility will support a Department of Defense contract in advanced technology aerospace manufacturing.

A key aspect of the original facility's transformational impact includes collaboration with educational and workforce development entities such as Career Source and Gulf Coast State College through the development and execution of a pre-employment training curriculum and course. With the company bringing specific skill set knowledge and a "train the trainer" approach, 28 recently hired technicians successfully completed the program by November 2018. These courses offer the opportunity, to those who meet entry criteria for high quality employment in a STEM career field with improved skill diversification within the disproportionately affected counties with the company or other advanced manufacturing companies. Florida State University – Panama City campus also introduced a Mechanical Engineering program in Fall 2018 in part to help support the company's request to help develop the talent pipeline. Furthermore, the company integrated into the Northwest Florida community by supporting STEM subjects through the local school district and other mentoring opportunities in the community. The company will also establish a paid internship program in 2019.



Summary of new potential project – Project Clear

The company is considering, building on its strong collaborative relationships with local partners in Bay County, to expand its footprint in the local area with a new project called Project Clear. The company through Project Clear supports the establishment of a new state-of-the-art, high-technology company facility (10 year lease plus extension options for a~120k sq. ft. building) at Venture Crossings in Bay County, Florida. The new facility will expand the manufacturing capacity for an existing company work scope and support a Department of Defense contract with long-term program expectations (30 years+) of providing original equipment, MRO services and spares. This long-term program will have the capacity to provide careers for not only today's workforce but also for future generations. The company will bring its proprietary technology and manufacturing know-how to the area, including training programs to enhance the skillset of the community for the company and PROJECT CLEAR or other advanced manufacturers. The company expects the economic impact of Project Clear to carry with it the extension of the economic impact of the related supply chain, increased employee spending and help establish an ecosystem which attracts other advanced manufacturing companies. The company believes these impacts have already yielded results with the recent announcement by ACMT to open their new facility in Bay County.

This proposal requests funding of \$50,000 per project job (total of \$7.35M) and anticipates the company to fund \$25.5M of the total investment thru the same period. This opportunity is in the targeted industry sector of Aerospace Manufacturing (NAICS code 336411) and has the potential to raise the sustainable family income for its employees and their families at an expected average wage of \$63,156, as compared to the Bay County average wage of \$37,035. This project offers the ability for individuals to diversify their current skill set beyond industries currently represented within the local market. This project has the ability to provide a military off ramp for those service members leaving the military in a complementary industry. The jobs and associated training offer marketable skills and advancement within the company, but also to outside companies. The company plans to continue its strong relationship with educational partners like Gulf Coast State College, Haney Technical Center and Florida State University to develop and build internship and co-op programs, with a concentration on STEM disciplines. The company would develop a preemployment training program through Gulf Coast State College.

The requested Triumph Funds would be paid to the public entity leasing the capital equipment to the company for PROJECT CLEAR to pay the lease payments during the initial period of operations, supporting the rapid establishment of the aerospace manufacturing capability in Bay County.
