TRIUMPH OF THE GULF COAST EXECUTIVE SUMMMARY LIBERTY VOLUNTEER FIRE DISTRICT – AERIAL LADDER APPARATUS FOR NORTH WALTON COUNTY PROJECT

Liberty Fire District, Inc. (LFD) is a Non-Profit, Special Independent Fire District created by the State of Florida Legislature. LFD covers 89 Square Miles of Central and Northern Walton County and provides Fire and Rescue Operations for it's citizens and visitors. LFD averages over 700 Emergency Calls each year. It is predominantly a rural, residential, low-income, area with some industrial, commercial areas and provides support to critical infrastructure of this Region. Critical Infrastructure includes 14 miles of US Hwy 331, 8.5 of US Hwy 90, 3 miles of Interstate 10, high power electric transmission lines, dual natural gas transmission lines, county maintenance facilities, industrial facilities, daycare and community churches, and active CSX Rail-lines.

Project needs assessment:

LFD and North Walton County is in dire need for an Aerial Ladder Apparatus for North Walton, FL. Within our District, we have 77 structures that are two stories or above. If you include areas within our Automatic Mutual Aid area of North Walton, we collectively have over 448 two story, or above structures. In addition, Apartments, Schools, Churches, Big-Box Stores, Industrial Areas, Hotels, Larger Maintenance Facilities, National Registry of Historic Homes (over 100 and all over 100 years old!), a Hospital and Nursing Home Facilities, etc.... The need for an elevated platform has existed in North Walton County for well over 20 years. As it currently stands, fire crews must utilize manual extension ladders, up to 24 ft. in order to fight multi-story structures. This is a dangerous and ineffective firefighting technique. The closest elevated platform would come from the City of Crestview, Fort Walton Beach, and South Walton Fire District. Crestview Fire, if available, would have a 45 minute response time, all others over 1 to 1 ½ hours. This is unacceptable in order to save a home, life, or business. North Walton County needs a Ladder Apparatus!

Why Liberty Fire?

- (1) Our LFD South Station is Centrally Located in North Walton County (3278 West Hwy 90).
- (2) LFD South Station was built to withstand 150 MPH winds in the event of severe weather for protection of this high value resource.
- (3) The station was built with an 80 foot drive-thru bay and 14' x 16' bay doors to accommodate this large apparatus. No other station in North Walton could house this equipment without a major renovation investment.
- (4) LFD boosts 32 Active Volunteer Firefighters, the largest volunteer fire agency in all of Walton County.
- (5) LFD already has 5" Large Diameter Hydrant Hose with Stroz connections (LDH). Most departments do not have this LDH in their current inventory. A 5" LDH effectively moves the location of the closure Hydrant to the address of the fire!
- (6) LFD's large Volunteer base, allows us to respond this needed apparatus to the entire Region on a Mutual Aid basis.
- (7) LFD has a very active training component, would require manufacturer training, daily inspections, training certifications, and proficiency training of all members and mutual aid partners.

(8) LFD would be responsible to complete annual certification and inspections on the ladder and pumps and maintain sufficient insurance on the apparatus.

We currently operate on just over \$160K per year and operate two fire stations (Central and South). LFD operates 14 pieces of apparatus and has a 30 member (FTE) volunteer firefighting and 1st Responder force (and growing)! Over 70% of our Nations Firefighters are Volunteers!

LFD is requesting assistance in obtaining a small NFPA Compliant 1901 ladder truck with a minimum of 75 ft elevated ladder (straight stick) and remotely controlled master stream aerial apparatus for North Walton County. Estimated Total Acquisition cost: \$900,000. LFD projected Cost Share of 20% would be \$180,000. A request from Triumph of the Gulf Coast is: \$720,000.

Project Benefits:

- Provides protection to all visitors (tourist) traveling the US Hwy 331 corridor to the Beaches of NW FL Panhandle:
- Provides direct fire protection to the homes and businesses and a financial reduction in homeowner/business insurance rates (Lowers ISO Ratings) in a Five Mile radius;
- Assists the entire Region and lowers ISO Ratings and Insurance rates for Florida Residents and Commercial and Government Structures in this area/Region;
- Enhances fire suppression capability and protects the Environment (reduces hazards, such as burning harmful combustibles and fuel leakage containment);
- Enhances Members and Certifications of Professional Volunteer 1st Responders
- Enhances New Membership and New Florida FF1 State Certified Firefighter Certifications!
- Enhances protection to tourists visiting Walton County Beaches and adds a new capability to all of North Walton County;
- Enhances Firefighter Safety by using technology for Fire Suppresion; Evacuation/Tornado Shelter to this area:
- By protecting Large Commercial Complexes, increases jobs in our local Commercial Industries.

Our Plan:

It is our intent to purchase a new apparatus for the South (Centrally located) Fire Station. Apparatus includes a NFPA 1901 Compliant, 500 GL booster tank, Freightliner chassis (Walton County has a new local Freightliner Dealer/Mechanics) and outfit this truck with necessary hose, nozzles and appliances. Also, a mandatory series of training events will be included by the Apparatus Manufacturer to include a Train-the-Trainer Class and Certifications for LFD and Mutual Aid personnel operating this ladder. This equipment allows our New Volunteer Firefighters (32 FTEs) to complete Certification Training using new NFPA 1901 Compliant apparatus. It is also necessary for immediate protection of the local community. Purchasing new equipment will provide an additional 12 new FTEs/jobs.

Please assist Liberty Volunteer Fire District in protecting our community for the next 20 Years! Coupled with an aggressive training/certification program, the Aerial Ladder for North Walton Project will ensure our volunteer firefighters go home safely after each and every call to action within our community and our entire Region!
