U.S. 331 INFRASTRUCTURE

The Walton County Economic Development Alliance (EDA) is partnering with the Walton County Board of County Commissioners and the City of DeFuniak Springs in seeking Triumph assistance with an approximate 4 mile water and sewer project on US 331 from approximately I-10 on the north to slightly below Poelkings Road on the South.

This project is entirely within a Rural Area of Economic Opportunity as defined by the State of Florida (DEO) and is expected to take approximately 18 to 24 months to complete, with engineering design and contract competing to start within 30 days of receiving the Triumph award.

The total cost of the project is expected to be about \$5 million, and Dewberry Engineers are working to determine a more finite price (including material costs, installation, and project management). The County will be providing approximately \$3 million and \$2 million is being sought from Triumph.

This project would serve not only the recently platted 300 acres on the west side of US 331 at I-10 (which is principally zoned for light commercial) all the way to a potential business park/industrial park south of Poelkings. The EDA is partnering with Walton County in negotiating for the purchase of approximately 225 acres (near Eglin Air Force Base's Site C-6) for this development.

In February 2018, during a Emerald Coast Military Fly-In to Washington D.C., a senior Pentagon official advised both Walton and Okaloosa counties to be prepared over the next 5 years for an influx of 2,000 military personnel and defense contractors from a northern facility in support of a weapons testing program. At a minimum, it is expected that the defense contractor positions will be at a pay level well above the Walton County average of \$36,000+.

Recently, we have been advised of a significant new program being implemented at Site C-6 which would result in creating an unspecified number of technical high paying positions.

The EDA has been utilizing the services of Mr. Larry Sassano (former head of Florida's Great Northwest) to help identify and recruit (especially military related) businesses along this corridor. One defense contractor has already indicated a plan to construct an office building with 40 employees over the next 3 years. Previous discussions with this contractor resulted in determining that the business would help serve as a magnet for other defense contractors. It is expected that the Site C-6 classified project would significantly support that.

There is also a project being recruited by the City along that corridor relating to technical air support for emergency helicopter transport technicians and related employees. Initial expectations are 10 to 12 higher paying jobs.

It is anticipated that the strong showing of good paying jobs along this corridor will result in an effort to further develop business segments along US 331 to the south, ultimately, at some point, reaching Choctawhatchee Bay.

Walton County would provide the necessary matching funds from the Restore Act. The County would oversee and administer the contract for the installation of the water and sewer systems. Once operational, the City of DeFuniak Springs would take over operating and maintaining both systems.

If successful in receiving Triumph support, Walton County, would have money set aside in a TIF (Tax Incremental Financing) fund, already established along this corridor to "bank" increased county-wide property tax revenues, in case there would be any necessary claw-back in the future. The City of DeFuniak Springs would also be setting aside 10% of any new water and sewer revenue along the corridor into an escrow account that would be maintained either for potential claw-back or in case of a catastrophe.

In general, this plan would provide a diversified economic growth opportunity, not solely dependent upon tourism, with a draw for good paying technology jobs. In addition, the development of the intersection of I-10 at US 331 could similarly serve as a distribution/logistics magnet for companies looking to service the Emerald Coast along both the I-10 and the US 98 (beach) corridors.
