EXECUTIVE SUMMARY

Collaborative Partnership

The Franklin County School District is dedicated to providing educational opportunities which will produce career ready graduates who are trained in leveraging their job skills to protect our fragile environment, preserve our cultural legacies, and create a brighter future for the community as a whole. Our goal is to provide students with the technological skills necessary for success in today's world, while also providing them with certification pathways that will allow them to pursue jobs which focus on the health of our local environment and its people through our science and agri-science programs, as well as the medical academy. Acquisition of this grant would allow the Franklin County School Board to immediately implement a drone certification program that by year 4 will be fully implemented and working towards complete sustainability. We are seeking this grant to expand our certification offerings to include the Small UAS Safety Certification and the Visual Line of Sight System Operator, both of which are provided through the Unmanned Safety Institute and on the CAPE Funding List as 0.2 and 0.1 weights, respectively.

Program Description and Objective

The Franklin County School Board's (FCSB) educational goals include utilizing and promoting community partnerships to support student learning in a manner in which 100% of our students graduate with a high school diploma or industry certification and a post-secondary plan. FCSB recognizes their obligation to provide both a quality education and career and technical training to produce students that are highly skilled and prepared to enter the workforce. Through meeting this obligation, the FCSB will be doing its part to promote economic recovery and business growth in our community. It is the intent of the FCSB to use Triumph funds to prepare Franklin County students for future occupations and careers which will be life altering for generations to come. While we celebrate the fact that 16% of our graduating seniors received their Associate of Arts Degree from Gulf Coast State College last week, we know that to provide CTE opportunities for the remaining 84% of our student population will allow them to obtain skills that will make their adult lives more prosperous.

Project Development

This, the second phase of our Environmental, Technical and Career Training will be used to hire a Drone Aviation Technician to train teachers and oversee the project, obtain drones and related peripheral equipment, provide safe and secure storage, purchase curriculum, and purchase certification exams. A portion of the funds will be used to hire a Coordinator to closely monitor and support the students enrolled in our dual enrollment program and in our Career Pathways. This position will lead to increased numbers of students graduating with either an Associate of

Arts Degree or with CTE certifications that will allow them to enter the workforce with a set of skills that are in demand and offer higher income opportunities.

Funding Sources


The FCSB will contribute approximately \$652,000 over the life of this proposal in the form of instructional salaries and benefits. This contribution represents 34.9% of the total project cost, and we are seeking funding from this grant to cover the remaining 65.1% of the total project cost.

Between the beginning of the 2019-2020 school year and the end of the 2023-2024 school year, there shall have been issued at least 410 certifications. At least 250 certifications will be earned in Small UAS Safety Certification, Visual Line of Sight System Operator, EKG, and Emergency Medical Responder. An additional 160 certifications will be earned in digital tools.

Timeline

The project timeline will begin immediately upon approval and will cover a 5 year period. The chart below depicts graduation rates within our student population for the past four years. A graph is also provided to show the number of industry certification exams taken in Franklin County and data comparing Franklin completers to those of surrounding counties. With the ability to enhance our CTE programs and add additional programs for students, we project a much needed increase in the number of industry certifications in specific fields, a trained and ready workforce, and graduation rates that will better mirror those of the state average. FCSB is pleased to report that 351 certificates/certifications have been earned so far this school year.
