

Applicant Information

Gulf Coast State College (GCSC)

Background of Applicant: Gulf Coast State College is a public institution of higher education serving Bay, Gulf and Franklin counties. One of 28 state/community colleges in the Florida College System, GCSC has 4 campuses located in Panama City, Southport, Tyndall Air Force Base and Port St Joe. The College offers over 150 academic programs including four bachelor's degrees, AA and AS degrees and numerous certificate programs. Currently GCSC has approximately 6,300 students with 35% of those students attending college full-time. The college's student:teacher ratio of 37:1 is lower than the state/community college average of 38:1. Gulf Coast State College is recognized as having the least expensive tuition and the least debt for graduating students of the other 28 state/community colleges in Florida and also for strong academic and workforce programs.

Eligibility

2. The Gulf Franklin Campus (GFC) of Gulf Coast State College located in Port St Joe, Florida is requesting funding to expand the number of students who can be served in the nursing programs offered at the campus. The requested funding would be used to expand the capacity of the campus in order to increase enrollment, completion, and job placement in the Certified Nursing Assistant (CNA), Practical Nursing (PN) and LPN to ADN Bridge (Registered Nurse) programs.

The increase in capacity of the campus would be accomplished by the creation of a nursing simulation center using the newest and most effective simulation equipment, technology, and trained faculty. The creation of the Nursing Simulation Center at the GFC would enable the nursing students to perform clinical training on-site at the GFC. Historically, the barrier to expanding the nursing programs at the GFC has been a shortage of clinical sites. The creation of the Nursing Simulation Center at the GFC will result in the following increases in the number of students who can be served in the nursing programs.

Certified Nursing Assistant Program (CNA): The Nursing Simulation Center would permit the CNA skills training to be offered twice weekly, decreasing the time to complete the program from 15 weeks to 8 weeks. The condensed CNA program could then be offered at least three times per year, increasing enrollment from the usual maximum of 12 students to 36 students. Additional classes could be offered based on community need.

Practical Nursing (PN): The creation of the Nursing Simulation Center would allow nursing students to perform clinical training on site at the GFC which would enable the PN program to offer two start dates a year, rather than one. This would double the enrollment potential from 36 to 72 each year.

LPN-ADN Bridge Program: The LPN-ADN Program is offered as a weekend option at the GFC and currently has a maximum of 18 students enrolled each semester. With the creation of the Nursing Simulation Center, the program could accept 22 students each semester, increasing the yearly enrollment from 36 to 44.

As a result of the creation of the Nursing Simulation Center at the GFC, enrollment would increase from the current 84 students to 152 students per year or 68 additional students. Over the 5-year scope of this request, the total increase in nursing students would be 340 students.

Historically, the completion rate for the three nursing programs has been consistently high at 85% and the employment placement rate is also consistently high at 95%. Given these completion and placement rates, the 340 increase in enrollments would result in 289 completers and 275 job placements.

The availability of 289 new nurses in the local communities will have a significant impact on the nursing shortage in the region and, a significant impact on the quality of life for these 289 nurses. As a result of the salaries that these new nurses are now able to earn, their ability to support themselves and their families will also have a significant fiscal impact on local economies.

The average starting salary for RNs in the local area is \$56,480 while LPN's start at \$37,700 and CNA's start at \$25,930. The per capita income in Gulf County is \$21,005 and the per capita income in Franklin County is \$23,524. In each case, the starting salaries for the graduates of the nursing programs at the GFC will be higher than the per capita income for the area and significantly higher for RN's and LPN's. The increase in trained nurses earning salaries from \$4,000 to \$35,000 higher than the per capita incomes in the local area will have a significant economic impact on these individuals and their communities. This increase in earnings will enable the new nurses to have more discretionary income to spend in the local area thus contributing to a positive economic impact on local businesses and the economy as a whole.

In addition to the ability to increase nursing program enrollments, completions and job placements at the GFC, the Nursing Simulation Center will also be available to community health providers, such as Sacred Heart Hospital on the Gulf, Weems Hospital, Cross Shores Care Center and other care centers in local communities to use to train new hires and test skill competency levels.

The timeline for implementation of this project is 5 years.

3. The proposed project is transformational because of the emphasis on using new simulation technology to complement and enhance the training that nursing students are receiving at the Gulf Franklin Campus.

In the Institute of Medicine (IOM) report, *To Err is Human: Building a Safer Health Care System*, simulation training is recommended as one strategy to prevent errors in the clinical setting. Human patient simulation is a relatively new teaching strategy that allows learners to develop, refine, and apply knowledge and skills in a realistic clinical situation as they participate in interactive learning experiences designed to meet their educational needs.

The use of human patient simulation as an instructional strategy can enhance patient safety and optimize outcomes, providing a means of allowing nursing students to “practice” critical thinking, clinical decision making, and psychomotor skills in a safe, controlled environment, without potential risk to a live patient. Errors can be allowed and corrected without concern for patient safety. The use of this new and developing technology is transforming nursing education programs across the country and the nursing programs and students at the Gulf Franklin Campus will benefit greatly from this new technology.

Transforming the GFC nursing programs through the use of simulation technology will help to ensure that the local communities served by these programs have an increased number of highly trained nurses serving the area in the future.

4. The data or information available to demonstrate the viability of the proposed project will include the following data points:

Enrollment: minimum of 340 new nursing students enroll from 2019-2024

Completion: minimum of 289 nursing students complete one of the three nursing programs

Placement: minimum of 275 nursing students become employed as a nurse (CNA, LPN, RN)

5. The impacts to the disproportionately affected counties will be measured over the long term by the increase in the number of nursing students who enroll in, complete and become employed as nurses in the region. See above for the expected numbers. In addition to more highly trained nurses working and caring for the citizens and visitors in local hospitals and care centers, these nurses will be earning salaries greater than the local per capita income, which over the long term should have a very positive impact on the local economies.

6. This project will be sustainable once the initial startup costs (equipment, facility remodels, faculty) are obtained through Triumph and all additional program offerings are implemented. The revenue generated from tuition and lab fees will cover the costs of the instruction in these three programs at the GFC. Local partners will also assist with funding through grants and foundation donations.

7. The deliverables for the proposed project will be measured by using state data regarding enrollments, completions and placement information for the Certified Nursing Program, Practical Nursing Program and the LPN-ADN Program offered at the Gulf Franklin Campus. The deliverables are:

Increase enrollment by 340 students

From these 340 new nursing students, complete 289 students.

Of these 289 completers, 275 will become employed as nurses from 2019-2024.

Priorities

2. The long-term economic growth potential of the disproportionately affected counties will be enhanced by this project by providing 275 highly qualified and licensed new nurses who will become employed in the local communities earning salaries that are higher than the per capita incomes in Gulf County (\$21,005) and Franklin County (\$23,524). Certified Nursing Assistants starting salaries in the area are \$25,930 which is an increase of approximately \$4,925 and \$2,406 in each case. The starting salaries of LPN's in the local area is \$37,700 which is significantly higher than either of the per capita incomes by \$16,695 and \$14,176. The starting salary for RN's in the area is \$56,480 which is \$35,475 and \$32,956 higher than the per capita income in Gulf and Franklin counties. These significantly higher starting salaries will provide individuals and families with additional income to spend which in turn, stimulates economic growth resulting in more small businesses providing goods and services in the local communities.

The Gulf Franklin Campus will continue to partner with the school districts in Gulf and Franklin counties in providing a career pathway for students in the two counties who are interested in a nursing career. The Certified Nursing Assistant to Licensed Practical Nurse to Registered Nurse is a very clear and structured career path. This career pathway enables a student to begin training and become a CNA, become employed as a CNA or continue training to become a PN. Once the student is a licensed practical nurse, the student may go to work as a LPN or continue their education to become a registered nurse. This nursing career pathway provides students in Gulf and Franklin counties with the opportunity to obtain their CNA, LPN and RN without leaving their homes and provides the opportunity to earn a credential and work while they are pursuing the next credential. The Nursing Simulation Center at the GFC will provide high school students in Gulf and Franklin counties who are interested in a nursing career (and may be taking health sciences courses in high school) with the opportunity to observe college nursing students in the Simulation Center and provide basic hand-on skills training while they are still in high school.

Discretionary Priority

3. Gulf and Franklin counties are included in the Northwest Rural Area of Opportunity as designated by the State of Florida (DEO). Both counties have been impacted by extraordinary economic events (BP oil spill) and natural disasters (Hurricane Michael). These events have had an extremely negative impact on the local economies of both Gulf and Franklin counties and a full recovery will take many years. During the recovery period, it is important to focus on

rebuilding communities and the tourism and fishing industries. It is also important to focus on building and enhancing other important industries such as health care. A viable health care system in a community not only provides improved health care services but also creates high skilled, high wage jobs which have a positive impact on the local economy. Establishing the Nursing Simulation Center at the Gulf Franklin Campus will increase the number of qualified and credentialed nurses available in the local communities.

Funding and Budget:

4. The potential award supplements exiting funding sources by providing startup funding needed to purchase equipment, including human patient simulators; remodel existing facilities to accommodate the simulation equipment; fund startup salaries of faculty until programs are self-sustaining. This funding is needed to cover the startup costs associated with establishing the Nursing Simulation Center at the Gulf Franklin Campus.

C. Once the Triumph Application is approved and the funding received, the remodel of classrooms in Building D and Building B will be started. It is anticipated that if the grant is approved by February 2020, the remodels can start immediately. It is anticipated that the remodels can be completed by May 2020. As soon as the remodels are completed, the equipment can be delivered and set up. The hiring process of new faculty will be completed by May 2020 in order to give faculty enough time to become familiar with the classrooms and new equipment. Full implementation of the Nursing Simulation Center is targeted for August 2020.

ADDENDUM FOR WORKFORCE TRAINING PROPOSALS

1. Program Requirements

A. The proposed Nursing Simulation Center will be located at the Gulf Franklin Campus (GFC) in Port St. Joe Florida. Port St Joe is in Gulf County. The location of the GFC is on the county line between Gulf County and Franklin County. Both Gulf and Franklin counties are disproportionately affected counties and students from both counties attend the nursing programs offered at the GFC.

The three nursing programs offered at the GFC include the Certified Nursing Assistant Program (CNA), the Practical Nursing Program (PN), and the LPN-ADN (RN) Program. The proposed Nursing Simulation Center will support all three programs by providing access to human patient simulators which will enable nursing students to receive hands on skill training in a real-life environment thus improving their ability to provide the appropriate care for patients in a variety of settings. The Nursing Simulation Center will also enable the GFC to increase the capacity of the nursing programs thus providing more opportunities for students in the area to pursue nursing as a career.

The three programs offered at the GFC provide a comprehensive career pathway for students interested in a career in nursing. The CNA program is the first step in the career pathway providing students with the opportunity to become a certified nursing assistant after 165 hours of instruction. Students completing the program and passing the certification exam are then able to become employed as a certified nursing assistant or the student can continue their education in the practical nursing program. Upon completion of the PN program and passing the certification exam, the student can become employed as a Licensed Practical Nurse or continue their education in the LPN to ADN program in order to become a RN. This career path approach provides students with the flexibility to receive training and become employed or continue their training and advance in the nursing profession.

B. The Nursing Simulation Center at the GFC will enhance the training opportunities available to nursing students in the local communities by increasing the number of nursing students who can receive training. The Nursing Simulation Center will also provide students access to state-of-the-art simulation equipment such as human patient simulators and to faculty highly trained in the use of this equipment. Access to the simulation equipment and the opportunity to learn on this highly technical equipment under the guidance of skilled faculty will increase the students' technical skills and knowledge of nursing.

The Nursing Simulation Center will increase the number of industry certifications or licensures earned by increasing the number of nursing students who can be enrolled in the nursing

programs at the GFC. As discussed earlier in the application, the creation of the Nursing Simulation Center has the potential to increase enrollment in the nursing programs at the GFC by 340 students over the next five years. With a completion rate of 85%, it is projected there will be 289 completers and with a placement rate of 95%, at least 275 nursing students would have received a minimum of one licensure, and a maximum of 3 licensures.

The Nursing Simulation Center at the GFC will strengthen career readiness initiatives by providing Gulf and Franklin County K-12 students the opportunity to visit the Nursing Simulation Center and observe nursing students using the equipment and observing the skills training, problem solving, and teamwork that the nursing students are exhibiting. The K-12 students will also have the opportunity to observe the type of work that CNA's, PN's and RN's are involved in. Gulf and Franklin County high school students in health science classes will also have the opportunity to use the simulation equipment.

The Nursing Simulation Center at the GFC will also encourage Gulf and Franklin County K-12 students with an interest or aptitude for science, technology, engineering, mathematics and medical disciplines to attend Gulf Coast State College , specifically the GFC in Gulf County, by introducing the students to the highly technical simulation equipment and highly trained faculty that are available in their communities. They will recognize that the highly technical training that is needed in these fields is available in their community and that they do not have to leave home to pursue this training, thus saving time and money.

C. The proposed Nursing Simulation Center will provide the students who enroll in the Certified Nursing Assistant Program, Practical Nursing Program and LPN-ADN Program at the Gulf Franklin Campus with high quality, state of the art training leading to transferable, sustainable workforce skills in nursing. Nursing students who successfully complete the training program and pass the related licensure exam will be qualified to work throughout the region in numerous hospitals including Sacred Heart on the Gulf and Weems Hospital and assisted living facilities and nursing homes throughout the region.

D. Gulf and Franklin counties

E. As a result of the creation of the Nursing Simulation Center at the Gulf Franklin Campus in Port St. Joe, the number of students who can be enrolled in the three nursing programs (CNA, PN , LPN-ADN) at the GFC has the potential to increase by 340 students over 5 years. (See previous response regarding how the capacity will be increased in question #2 under Eligibility in general application). Based on a historical completion rate of 85%, it is projected that there will be 289 completers of at least one of the nursing programs. Based on a historical placement rate of 95%, it is projected that at least 275 of these completers will become employed as either CNA's, LPN's or RN's.

As discussed previously in the application, students completing the CNA, PN, and LPN-ADN programs will be able to earn starting salaries that are considerably higher than the per capita incomes in the local communities served by the GFC. These increases in salaries range from \$2,406 to \$4,925 more for CNA's, licensed practical nurses earn \$14,176 to \$16,695 more than the per capita income in Gulf and Franklin counties and RN's earned between \$32,956 and \$35,475 more than the per capita incomes. These considerably higher salaries will contribute significantly to the economic recovery of the local communities by providing additional discretionary income to a minimum of 275 newly employed nurses in the local communities impacted by the oil spill. These increased incomes will enable the nurses to increase their standard of living, including pursuing home ownership, and purchasing more durable and non-durable goods. This increase in spending will have a significant ripple effect on the local communities impacting local businesses that provide goods and services, thus increasing their sales and profits. The growth in the local economies as described above will encourage more businesses to locate in the area or expand in the area, which will enhance economic diversification through the creation of new and different businesses and industry. This economic growth and diversification will enhance the economic outlook for the communities in the local area. In addition to promoting economic growth and diversification, the Nursing Simulation Center at the GFC will enhance the Health Care Services targeted industry by providing a highly skilled nursing workforce trained in the latest technology.

2. Additional Information

A. The Nursing Simulation Center at the Gulf Franklin Campus is an expansion of the existing three nursing programs offered at the campus. The Nursing Simulation Center will increase the number of nurses that can be trained as CNA's, PN's or RN's by 340 students over 5 years. This increase in enrollment is possible through the use of state-of-the-art human patient simulators that will enable more classes to be offered and will provide nursing students with hands on experiences that can duplicate much of the skill training provided through clinicals. The Nursing Simulation Center, equipped with the latest in simulation equipment, will greatly enhance the training that can be received at the GFC by providing students with in depth, extremely realistic hands on skill training. The funding that is being requested for this proposal is needed as seed money to purchase the costly simulation equipment, remodel existing facilities and to initially assist with the salaries of the credentialed faculty that will be needed to establish the Nursing Simulation Center. The requested funding will be supplementing but not supplanting existing funding sources.

B. The training will be delivered in the classroom, the Nursing Simulation Center and at clinical sites (hospitals, rehabilitation centers, assisted living facilities, nursing homes, and urgent care facilities). The classrooms and the Nursing Simulation Center are located at the Gulf Franklin Campus in Port St. Joe. The clinical sites are in Gulf, Franklin and Bay counties.

C. It is anticipated that the addition of the Nursing Simulation Center at the Gulf Franklin Campus will increase the enrollment by 340 nursing students over 5 years. It is anticipated that 289 (85%) of the enrolled students will complete the program and 275 (95%) will become employed.

D. The Certified Nursing Assistant program is 165 hours.

The Practical Nursing Program is one year

The LPN to ADN Bridge Program/Weekend is 2 semesters

E. It is anticipated that by the fifth year of the proposal the Nursing Simulation Center will be self-sustaining through tuition and fees paid by students enrolled in the nursing programs.

F. Students completing the Certified Nursing Assistant Program will receive a certificate from GCSC and be eligible to sit for the Certified Nursing Assistant certification/licensure exam that is required to become employed as a CNA in Florida.

Students completing the Practical Nursing Program will receive a certificate from GCSC and are qualified to sit for the Licensed Practical Nurse Exam. Students passing this exam receive licensure as an LPN which is required to become as an LPN in Florida.

Students successfully completing the LPN-ADN Bridge Program receive an Associate in Science Degree in Nursing and are eligible to sit for the NCLEX-RN licensure exam which is required to become employed as an RN in Florida.
