EXECUTIVE SUMMARY

Collaborative Partnership

Wakulla District Schools/Lively Technical College/Federal Aviation Administration (W.L.FAA) is dedicated to seeing our economic infrastructure along the Gulf Coast restored through the education of its community members. Wakulla District Schools is a prek-adult public school district, Lively Technical College functions as a post-secondary technical college, and the Federal Aviation Administration operates as an employer. The goal is to work between Wakulla District Schools and Lively Technical College to expand our Aviation Powerplant and Airframe Mechanics program (program numbers T640300 and T640400). Targeted industry analysis shows workforce training with regard to aircraft mechanics and service technicians are required for enhancement of disproportionately affected counties. Wakulla District Schools is partnering with Lively Technical College, the FAA, and Embry-Riddle Aeronautical University - Daytona to provide pathways for students and adults to gain the necessary skills certifications and credentials for employment in the aviation industry.

Program Description and Objectives

The mission of this proposal is to meet regional career-oriented education and workforce needs for the community. It operates to lead workforce training in the region by utilizing industry driven educational solutions and community partnership to equip students to meet the needs of local and global employers. Through education and workforce development, we believe that our training programs can transform economic recovery in our region. In order to strengthen the region's economic base and encourage business growth, it is our obligation, goal and commitment to provide training and education that will meet workplace needs with a highly skilled and job ready workforce. Therefore W.L.FAA propose to use Triumph funds to move from 37 FAA Certifications per year to 315 FAA Certifications over seven years. W.L.FAA is requesting a bonus of \$3,000.00 for each FAA certification above 315 and not to exceed 500.

Project Development

W.L.FAA will seek to expand and increase the number of participants enrolled in the postsecondary Aviation Powerplant and Airframe Mechanics program by adding an additional night time course offering, expanding the daytime program and increasing the number of dual-enrolled high school students participating in the program.
