#### 1. Title: Project Recall

#### \*\*\*This is a confidential project pursuant to F.S. 288.075

2. Description: The Santa Rosa Economic Development Office has successfully worked to recruit Project Runner, a distribution company locating in the Blackwater Industrial Park and creating 400 jobs. Project Recall is a supplier to Project Runner and will bring 150 additional jobs at 115% of the average county wage. Project Recall is intending to construct a \$12 million-dollar facility in proximity to Project Runner's distribution facility.

All infrastructure is in place, or in progress, except for wastewater treatment capacity. The current wastewater treatment facility is near capacity and cannot accommodate new industry beyond Project Runner. In order to provide capacity for Project Recall, along with the expectation that additional suppliers will need to locate in proximity to Project Runner, the City of Milton is requesting funding to construct the North Santa Rosa Regional Water Reclamation Facility (NSRRWRF) and increase capacity to allow development of Santa Rosa County industrial parks. Competition for this project includes the ready sites available just across state lines, and without wastewater capacity these jobs will be lost to our neighboring states.

The City of Milton has secured the bulk of funding for the new facility and is in need of the last \$6 million to complete this crucial project, encourage business and industry to locate in Santa Rosa County, and spur job creation.

#### **Approximate Project Parameters**

- Number of Jobs: 150
- Average Wage: \$42,000
- Capital Investment: \$12 million
- **3.** Location: Project Recall is intending to locate at a privately-owned industrial park in Santa Rosa County, strategically located along Interstate 10. The company would utilize approximately 10 acres.

The proposed wastewater treatment facility will be located just north of the Santa Rosa Industrial Park on City of Milton property. The effluent disposal portion of the project begins at the City of Milton Wastewater treatment plant located within the City of Milton in Santa Rosa County, and terminates at the effluent disposal site located north of Naval Air Station Whiting Field.

# 4. How the proposed project promotes economic recovery, diversification and enhancement of the disproportionately affected counties:

(a) Economic Recovery: The Santa Rosa Board of County Commissioners has worked for years to bring higher paying jobs to the County. One of the most telling statistics of the county can be seen on the Northwest Florida FORWARD County Snapshots. The net inflow/outflow of commuters is largely outward from Santa Rosa County, which

means workers are commuting outside the county to higher paying jobs. They are commuting to the metropolitan core areas of Pensacola or Fort Walton Beach or to Crestview. The downturn of the economy in 2008 and the Deepwater Horizon Oil Spill in 2010 both hit the county's economy very hard (unemployment rose from 2.8 in 2006 to 9.5 in 2010) because of the reliance on growth in the construction/housing industry and tourism for jobs and revenues.

Years later, the choice among better paying jobs in the county is still limited. As of 2016 according to the Northwest Florida Forward County Snapshots, a publication of Florida's Great Northwest, the top five industry sectors by employment are, in order, elementary and secondary schools, limited service restaurants, full-service restaurants, the federal government including military, and local government. Missing from the list are the types of industries that can create an industry cluster around a major consumer of other businesses products.

- (b) Diversification: Santa Rosa County has relied heavily upon military, tourism and agriculture, all of which are subject to unpredicted devastating events that can wipe out expected revenues, such as the Deepwater Horizon Oil Spill, weather conditions and base realignments. Development of the distribution industry will not only diversify the economy but would also provide stability as the need increases nationally and locally for distribution hubs.
- (c) Enhancement of Disproportionately Affected Counties: Santa Rosa County and the region of disproportionately affected counties will be enhanced:
  - i. Distribution and supporting industries will bring jobs with higher pay.
  - ii. Aligns with the Northwest Florida FORWARD regional strategic initiative by supporting the manufacturing industry by providing transportation for its products and supporting the water transportation industry by providing land-based logistics.
  - iii. Will create net new jobs in support of a targeted industry.

iv. Provides a wider regional impact as evidenced by the U.S. Cluster Mapping Project, Institute for Strategy and Competitiveness, Harvard Business School, which shows Northwest Florida as a cluster for transportation and logistics.

- 5. Proposed Timeline: Project Recall would like to break ground in 2021, with construction lasting approximately 18 months. Design and permitting are complete for the NSRRWRF project, and construction can commence immediately upon receipt of funding.
- 6. Disproportionately affected counties impacted by the proposed project: Due to the strategic location on Interstate 10 and Hwy 87 in Santa Rosa County, job creation for Project Runner, Project Recall, and other future suppliers will include workforce from Escambia, Santa Rosa, and Okaloosa Counties all of which are within a 30 minute drive time.
