Walton County School District/Emerald Coast Technical College respectfully submits this letter of intent to apply for funding as provided by Triumph Gulf Coast, Inc., through the Skilled Labor Recovery Fund to address the need for construction trades workers to aid in the economic recovery of Northwest Florida following Hurricane Michael. This application is for the initial funding cycle: May 1, 2020 – October 31, 2020.

Walton County School District proposes to provide career education and training for a minimum of twenty (20) students/workers in the following construction trades: Electricity (10) and HVAC (10) during the period May 1, 2020, through October 31, 2020. Students will be expected to earn a minimum of two (2) appropriate CAPE certifications during this period, for a total of 40 CAPE certifications. Florida Department of Education approved curriculum / classes will be offered on the campus of Emerald Coast Technical College, the district's postsecondary educational institution located at 761 North 20th Street, DeFuniak Springs, Florida. In addition to the general adult population, the project will work at recruiting high school students in grades 11 and 12 for dual enrollment opportunities. Real world skills application will be a major feature of the training.

"The 2019-2020 Regional Demand Occupations List as published through the Department of Economic Opportunity (DEO) Bureau of Labor Market Statistics (LMS) lists the labor market needs of Florida's business community and encourages job training based on those needs." https://careersourcencfl.com/employers/, visited 02/20/2020. This list identifies electrician and HVAC technicians for Region 2, Okaloosa and Walton Counties as growing at an annual rate of 1.28% and 1.97% respectively. For the 2019-2020 period, 78 job openings are projected for electricians and 82 job openings are projected for HVAC technicians. This project will work to help address anticipated demand for these trades in the construction sector, thereby helping support economic recovery in the region. The project proposes to submit verification of 40 CAPE industry certifications earned by students during the project period May 1, 2020, through October 31, 2020. Industry certification will provide validation of skills to area employers, enhancing employment possibilities for students while helping increase efficiency and effectiveness of the industry.

Thank you for the opportunity to submit this letter of intent to apply along with the completed application for funding to help address this labor market need and to aid in our region's economic recovery.

Priority: Generate maximum estimated economic benefits, based on tools and models not generally employed by economic input-output analyses, including costbenefit, return-on-investment, or dynamic scoring techniques to determine how the long-term economic growth potential of the disproportionately affected counties may be enhanced by the investment.

Through implementation of this "Fast Track" training project, economic benefits to the region include quickly increasing the number of certified, well-prepared electricians and HVAC technicians in the general construction sector in the region. The number of electricians needed for Region 2, Okaloosa-Walton is projected at 78 as reported on the 2019-2020 Regional Demand Occupations List, reflecting a growth rate of 1.28%. A minimum of ten well-prepared, credentialed workers who will be able to continue their training as electricians will help meet over 10% of this estimated demand within the first year of the project as the students graduate and enter the workforce.

The number of HVAC technicians needed for Region 2, Okaloosa-Walton is projected at 82 as reported on the 2019-2020 Regional Demand Occupations List, reflecting a growth rate of 1.97%. A minimum of ten well-prepared, credentialed workers who will be able to continue their training as HVAC technicians will help meet over 10% of this estimated demand within the first year of the project.

Priority: Increase household income in the disproportionately affected counties above national average household income.

This "Fast Track" project proposes to move workers' wages toward the national average household income by providing training to secure wages that are estimated at \$26,416 entry/\$40,123 median for electricians in the region and \$31,990/\$41,683 median for HVAC technicians in the region. Wage growth would be expected to continue to increase as workers gain additional experience in the field.

Priority: Leverage or further enhance key regional assets, including educational institutions, research facilities, and military bases.

The Norwest Florida region is home to excellent educational institutions. Emerald Coast Technical College is the Walton County School District's only postsecondary educational institution, awarding postsecondary certificates along with industry certification and licensure as appropriate. At no cost to the student or family, district high school students are provided the opportunity to enroll in postsecondary career certificate programs concurrent with their high

school education. Completion of the postsecondary career certificate may then be articulated to state college programs. The electricity and HVAC "Fast Track" programs will offer technical dual enrollment opportunities for high school students and also make available the potential for achieving state college credit for students who complete these certificate programs and elect to enroll in appropriate programs locally or statewide. Along with these continuing education pathways, industry certifications will help students progress along meaningful career pathways.

Priority: Provide outcome measures.

This Triumph Gulf Coast, Inc., "Fast Track" project proposes to provide career education along with the opportunity to earn a minimum of two (2) industry recognized certificates per student to a minimum of ten (10) students in Electricity and ten (10) students in HVAC, for a total of 40 industry credentials during the period May 1, 2020, through October 31, 2020.
