Dear Ms. Henderson:

Thank you very much for the consideration of our proposal "UAS Pilot Boot Camp for Exiting Military" (#210) at the Triumph board meeting on March 3. Based on the discussion at that meeting, we would like to amend the budget as indicated in the attachment. This budget amendment will reduce the amount being requested from Triumph from \$3,033,438 to \$2,259,063. It will increase the GCSC funding from \$781,562 to \$955,937.

With these revisions, the percentage of funding from each partner would be:

Triumph	\$2,259,063	(<mark>56%</mark>)
GCSC	\$955,937	(24%)
Unmanned Safety Institute	\$790,000	(20%)

In addition to the above budget amendment, we would also like to include the following assurances:

Gulf Coast State College intends to offer the UAS Boot Camp beyond the initial four years indicated in the application as the length of the program. Based on the employment projections indicated for remote pilots, it is our belief that the demand for remote pilots will continue to grow in our region. It is our intent to meet this demand by offering the Boot Camp as often as there is demand and as long as there is demand. We will also offer the program at any of our campuses or instructional sites in order to meet this need and make it more convenient for students.

It is also our intent to include not only exiting military but also the spouses of exiting military when marketing and recruiting for this program.

We hope that this budget amendment and assurances address the issues that were discussed by board members at the board meeting. If you have any questions or need additional information, please let me know.
