FIRST AMENDMENT TO

GRANT AWARD AGREEMENT

(Northwest Florida State College/Project #187)

THIS FIRST AMENDMENT TO GRANT AWARD AGREEMENT (this "Amendment") is made and entered into as of _______, 2020, by and between TRIUMPH GULF COAST, INC., a Florida not-for-profit corporation ("Triumph"), and the "), and NORTHWEST FLORIDA STATE COLLEGE ("NWFSC").

WITNESSETH:

WHEREAS, Triumph and NWFSC are parties to that certain Grant Award Agreement dated August 16, 2019 (the "Agreement"). All capitalized terms herein shall have the meanings set forth in the Agreement; and

WHEREAS, NWFSC has requested that certain amendments be made to the Agreement; and

WHEREAS, Triumph is agreeable to certain amendments to the Agreement as described herein.

NOW, THEREFORE, in consideration of the mutual covenants, promises herein and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Triumph and NWFSC hereby agree as follows:

1. **Amendment to Section 4.** Section 4 of the Agreement is hereby deleted and replaced in its entirety with the following:

"4. Funding of Grant:

- 4.1 **Funding**. As more fully shown in the Budget (as defined in Section 5.2 below), the Grant shall be allocated as follows:
 - (a) \$342,496 of the Grant funds shall be allocated for instructor salaries and fringe benefits, to be funded in the amounts and at the times as set forth in the Budget;
 - (b) \$109,297 of the Grant funds shall be allocated for equipment, to be funded in the amounts and at the times as set forth in the Budget

- (c) \$1,911,923 of the Grant funds shall be allocated for construction, to be funded in the amounts and at the times as set forth in the Budget; and
- (d) \$400,000 of the Grant funds shall be allocated for renovation of existing buildings, to be funded in the amounts and at the times as set forth in the Budget.
- 4.2 Conditions to Funding of the Grant. Not more than once per calendar month, NWFSC shall submit to Triumph a separate Request for Funding in the form of Exhibit "A" attached hereto and incorporated herein (a "Request for Funding") for each Budget category in accordance with the Budget and shall submit information pursuant to a SmartSheet system by NWFSC's authorized users listed in Exhibit "C" attached hereto and incorporated herein. Each Request for Funding shall include (A) reports in budget categories with copies of general ledger detail for the Project account (as defined below) showing itemized expenditures, (B) invoices from architects, engineers, contractors, materialmen, and other vendors performing the construction; (C) invoices, purchase orders, or contracts from vendors providing equipment, materials, and services; (D) payroll ledgers, state and federal payroll returns, and other employment data, (E) documentation evidencing the completion of the work that is the subject of the requested funding, (F) to the extent that any portion of the current funding request is for reimbursement of amounts already paid by NWFSC, copies of cancelled checks evidencing that NWFSC paid vendors, (G) evidence of payment and use of Matching Funds (as defined in Section 5.2 below), and (H) such other documents as Triumph shall require in order to determine that the funding is consistent with the purposes of the Grant. NWFSC shall notify the Triumph Program Administrator via email each time a Request for Funding is submitted. Each Request for Funding shall aggregate not less than \$50,000 of eligible Upon Triumph's receipt of (a) notification to the Program funding items. Administrator, and (b) a Request for Funding that includes all required supporting documents, Triumph shall have forty-five (45) days from receipt to review and either approve or disapprove of a Request for Funding. If Triumph approves a Request for Funding, then it shall fund the approved amount to NWFSC within thirty (30) days after approval. If Triumph disapproves a Request for Funding, Triumph shall deliver a notice of disapproval within such forty-five (45) day period that states the reasons for such disapproval. If the stated reasons for disapproval can be cured by NWFSC's submittal of missing or corrective items, NWFSC shall have thirty (30) days following receipt of the notice of disapproval to submit such missing or corrective items. If Triumph fails to notify NWFSC of its disapproval of the Request for Funding within forty-five (45) days of receipt, such Request for Funding shall be deemed disapproved.

All amounts funded to NWFSC pursuant to a Request for Funding shall be (check as applicable):

____ paid to NWFSC as a disbursement, in which case NWFSC shall then pay vendors supplying equipment, materials, or services, and/or to employees performing work, in each case consistent with the Budget; or

____ X__ paid to NWFSC as a reimbursement of amounts NWFSC has already paid to vendors supplying equipment, materials, or services, and/or to employees performing work, in each case consistent with the Budget, in which case the

Grant funds shall be retained by NWFSC.

None of the Grant shall be used as a reimbursement of items purchased by NWFSC prior to the date of this Agreement. None of the amounts paid by NWFSC in connection with the invoices submitted in a Request for Funding and then funded by Triumph shall also have been or will in the future be in any manner (a) reimbursed, returned, refunded, rebated, or otherwise credited to, NWFSC by any contractor, materialman, vendor, or any other person or entity, or (b) paid, reimbursed, returned, refunded, rebated, or otherwise credited to NWFSC by the State of Florida, the United States, or any agency or instrumentality of any of the foregoing, whether under any grant or loan program or other method of contribution, it being expressly understood and agreed that NWFSC shall not receive payments, refunds, reimbursements, rebates or credits from any sources in amounts collectively exceeding 100% of the amounts paid or owing by NWFSC.

NWFSC shall seek funding only for costs as shown or contemplated under the Budget. All amounts paid by NWFSC with respect to the Project shall be supported by properly executed invoices, contracts, or vouchers evidencing in proper detail the nature and propriety of the charges. Any check or order drawn by NWFSC with respect to any item which is or will be chargeable against the Project account will be drawn only in accordance with a properly signed voucher then on file in the office of NWFSC stating in proper detail the purpose for which such check or order is drawn. All checks, invoices, contracts, vouchers, orders, or other accounting documents pertaining in whole or in part to the Project shall be clearly identified, readily accessible, and, to the extent feasible, kept separate and apart from all other such documents.

Notwithstanding the foregoing, Triumph shall not be obligated to make the final disbursement of the Grant until NWFSC provides satisfactory evidence that NWFSC has properly and fully expended all Matching Funds.

Triumph will honor requests for funding; provided, however, that Triumph may elect by notice in writing not to make a payment if:

- (a) There is missing or incomplete documentation;
- (b) The Request for Funding seeks funding for items other than as described above or as shown in the Budget;

- (c) The amount requested for funding under the Request for Funding, together with all amounts previously funded under the Grant, would exceed the \$2,763,716.00 maximum amount of the Grant; or the amount requested for funding under the Request for Funding for a particular Budget category, together with all amounts previously funded for such Budget category, would exceed the maximum amount allocated to such Budget category; or NWFSC failed to use any Grant funds funded to date in the amounts and for the purposes stated in the Budget;
- (d) NWFSC made a misrepresentation or omission of a material nature in the Grant Application, or any supplement or amendment to the Grant Application, or with respect to any document or data furnished with the Grant Application or pursuant to this Agreement;
- (e) There is any pending litigation with respect to the performance by NWFSC of any of its duties or obligations which may jeopardize or adversely affect the Project, this Agreement, or funding of the Grant;
- (f) NWFSC has taken any action pertaining to the Project which, under this Agreement, requires the approval of Triumph, and NWFSC failed to obtain such approval;
- (g) There has been a violation of Sections 9.1, 9.4, and/or 9.5 of this Agreement;
- (h) NWFSC is in material violation, default, or breach of or under any provision of this Agreement;
- (i) NWFSC is in breach of any material representation or warranty contained in this Agreement;
- (j) Any federal, state, or local organization or agency (including NWFSC) providing financial assistance to the Project has revoked, suspended, or terminated that financial assistance to the Project, including, but not limited to, the Matching Funds;
- (k) The Matching Funds are not being used for the intended purposes and in the amounts and at the times as set forth in a schedule of expenses approved by Triumph, and/or NWFSC has failed to provide Triumph with evidence of payment of the Matching Funds toward completion of the Project;
- (1) With respect to previous fundings of the Grant and payments under Contracts, NWFSC has failed to pay, or has failed to provide Triumph with evidence of payment of, the Grant for the purposes of such funding. Such evidence shall include, but not be limited to, payroll ledgers, state and federal payroll returns, job descriptions, cancelled checks, wire transfer confirmations;

- (m) Prior to the Completion Deadline (as defined in Section 5.1 below), NWFSC has abandoned or discontinued the Project, or for any reason the commencement, prosecution, or timely completion of the Project by NWFSC is rendered improbable, infeasible, impossible, or illegal;
- (n) All or any portion of the requested funding includes funding for items that are outside the scope of the Project that is contemplated under the Budget;
- (o) One or more of the Contracts previously approved or deemed approved by Triumph have been modified, amended, or terminated, or have been subject to a change order, without the prior written consent or deemed approval of Triumph; provided, however, that any change order under \$5,000 shall not be subject to approval under this Agreement;
- (p) NWFSC shall have annually failed to make reasonable good faith efforts to obtain Business Donations in accordance with Section 5.12 below, and/or shall have failed to provide Triumph with satisfactory evidence of such efforts. Such evidence shall include a spreadsheet listing the Business Donations, the donors, and NWFSC's determination of the fair market value of the Business Donations, together with the latest sample form of letter or other communication requesting such Business Donation;
 - (q) A Budget category has been increased or decreased by more than 5%;
- (r) Completion of the Project is not on schedule for completion by the Completion Deadline;
- (s) NWFSC has failed to maintain in full force and effect all insurance required under Sections 5.4 and 5.10 below;
- (t) NWFSC is not in compliance with all applicable environmental laws and regulations in accordance with Section 5.5 below;
- (u) NWFSC is not in compliance with the competitive bidding requirements set forth in Section 3 above; and/or
- (v) NWFSC is not in compliance with the equal employment opportunity and other labor provisions as required by Section 9.3 below."
- 2. **Amendment to Exhibits:** The form of Application for Disbursement attached to the Agreement as Exhibit "A" is hereby deleted and replaced with the form of Request for Funding attached hereto as Exhibit "A" and incorporated herein, and all references in the Agreement to an Application for Disbursement shall hereafter mean and refer to a Request for Funding. The Budget/Timeline attached to the Agreement as Exhibit "B" is hereby deleted and replaced with the form of Budget/Timeline attached hereto as Exhibit "B" and incorporated herein, and all references in the Agreement to the Budget shall hereafter mean

and refer to the Budget attached hereto. The SmartSheet authorized users referenced in Section 4.2 above are listed in **Exhibit "C"** attached hereto and incorporated herein, which Exhibit "C" shall be deemed added to and incorporated into the Agreement as Exhibit "C" thereto.

3. **No Other Amendments**. Except as expressly provided above, the Agreement shall remain unmodified and in full force and effect.


