Dear Senator Gaetz,

Please find enclosed Tallahassee Community College's application for the Triumph Infrastructure and Logistics Training Fund (ILT). This project will be transformational for our region and is uniquely positioned to help deal with the fallout of job loss and economic insecurity in our region because of COVID-19.

Under this project the College will create two different programs. The first program will be a Masonry program where students will earn three different certificates. The second programs will be a Commercial Vehicle Driving, where students will earn their CDL certification. The cost per each certificate is \$982.

#### **Project Description:**

TCC is committed to ensuring that local residents have an opportunity to secure a skill that will afford them the ability to make a living and contribute to the workforce immediately. The training identified is in demand locally, regionally and nationally and will offer individuals an opportunity to immediately connect with employment. More importantly, the skills being taught are essential to our workforce thus reducing the risk that these individuals would be impacted due to economic emergencies such as COVID-19. Lastly, the training has the potential for those who desire to return and receive additional training and credentials (i.e. stackable) to support their continued progression and promotion in the workforce.

It should be noted that each individual who participates will be eligible to apply for a Fresh Start scholarship of at least \$300.00 based on their current employment situation.

#### **Training Location:**

The training will be delivered in Wakulla County. Note TCC currently has 2 facilities in Crawfordville, FL. Therefore, it is our intent to reduce the burden of individuals needing to travel a great distance from their homes or surrounding communities to receive this training.

### Number of students projected to be trained:

- Masonry 14 (Students would earn 3 certifications OSHA, CORE and Level 1) The Level 1 certification is attached to the CAPE funding list. There will be 2 classes delivered. Each class will consist of 210 clock hours and will be taught in the evenings.
- Commercial Vehicle Driving 30 (Students would earn their CDL industry certification). The CDL certification is attached to the CAPE funding list. There will be 6 classes delivered. Each class will consist of 175 hours and will be taught during the day.

We appreciate the opportunity to submit this application and are looking forward to providing any additional information.
