Brief Description of Individual/Entity/Organization:

The Okaloosa County School District (the "District") is home to approximately 32,000 K-12 students who attend forty-two public (42) schools, three of which are public charter schools. Okaloosa County is also home to Eglin Air Force Base, Hurlburt Field, and a 7th Special Forces group. The District is privileged to count the 6,000 dependents of active duty military personnel among its students (approximately 20% of our enrollment). The District is active in developing and implementing Career Technical Education programs that provide numerous certification opportunities for students.

The Okaloosa County School District is the sole applicant for this funding, however, the District will seek to develop formalized relationships with recognized industry leaders, university-level programs if applicable, and local economic development entities to ensure that the outcomes associated with this program are credential-based, forward-thinking, and place Okaloosa County students in the best position to succeed and support the overall economic development of the region. The project is being submitted to the Okaloosa County Board of County Commissioners at its next meeting.

REQUIRED EXECUTIVE SUMMARY

Application of Artificial Intelligence (AI) in logistics and distribution is an incredibly diverse and expanding field. The direct impact of AI in these areas is felt by anyone who has ever ordered something from Amazon or any other service and had it delivered in 24 hours. Before that package arrives, software has analyzed volumes of data to provide the optimal way to complete the task. This type of analysis is often referred to as Narrow AI, and it is so much more than simply identifying the best route to take to deliver a product. It's also the analysis of how to obtain, produce, store, and distribute goods in the right quantities and qualities at the right time for the end user.

The impact of Narrow AI on logistics and distribution cannot be understated. A recent report from McKinsey Analytics estimated that the potential economic-value creation from Artificial Intelligence in the next 20 years in supply chain alone at \$1.3 trillion dollars. Forbes Insight research showed that 65% of senior transportation-focused executives believe that logistics, supply chain, and transportation have brought about "an era of profound transformation". Going forward, every business that deals in the acquisition, storage, and distribution of goods on any significant level will be dependent on AI to stay competitive in the marketplace. That certainly includes businesses in the counties adversely impacted by the Horizon oil spill.

The Okaloosa County School District recognizes the intensity and pace at which Narrow AI is being developed and has identified a gap in K-20 education in Northwest Florida that needs to be filled. The District is intent on developing a transformational program that produces students with industry-recognized credentials in the area of AI – Logistics and Distribution by the time they graduate. In doing so, the District will be promoting the ongoing economic recovery of Northwest Florida.

To this end, the District is seeking \$828,000 in Triumph Gulf Coast funding from an overall sixyear estimated budget of \$5,020,200 to develop an AI – Logistics and Distribution program. The funding requested in this grant will support initial salaries, curriculum, professional development, and equipment and supplies through the developmental phase of the program which includes a planning year and Year 1. It is anticipated that by Year 3, the program will approach self-funding status through the Florida Education Finance Plan (FEFP) and earned CAPE certifications (See proposed timeline and estimated budget below). Following a planning year, the AI-Logistics and Distribution program will be implemented in 2022-2023 in an elementary, middle and high school feeder pattern in Okaloosa County in grades 4, 6, and 9, respectively. The program will expand in 2023-2024 to grades 5, 7, and 10 in those schools and will also be implemented in a second feeder pattern. Growth through grade progression will continue through in both feeder patterns through grade 12.

The grant-funded planning year will give the District the ability to identify and recruit industry partners, possibly including our military community, and to identify certifications that will align student outcomes with industry requirements. The District will take advantage of any current Logistics and Distributions certifications that exist on the CAPE Industry Certification Funding List if they are aligned to our program outcomes. The District expects that new certifications will need to be adopted as this is a new area of focus in K-12 education.

The District recently launched its Kids C.O.D.E initiative that teaches coding skills to elementary school students throughout Okaloosa County in an after-school format. We believe the skills learned

in this program by our younger elementary school students will serve as a tremendous foundation for those who progress into the AI – Logistics and Distribution program.

To the extent that a charter, private, or home school student can benefit from access to the AI - Logistics and Distribution program, they would be welcome to participate as a guest student. Or, the District will share curriculum resources and offer professional development to any non-traditional school seeking to start a similar program on its own campus.
