Project Gamestop - Wakulla - TGC Pre-Application

EXECUTIVE SUMMARY

Proposed project or program and anticipated outcomes:

Project Gamestop is a manufacturer and distributor of canned beverages whose only considerable production facility is leased in central Florida. In the lease situation, the company must compete for use of the facility with other beverage makers. By establishing a dedicated owned and operated facility in Wakulla County, the company can better control inventory and scale the product to serve more markets in Florida and the southeastern United States.

(i) the amount of funds being sought from Triumph Gulf Coast


Wakulla County is requesting a total of \$500,000 from Triumph Gulf Coast to support the cost of fixed assets. This number is based on the number of local jobs the company will provide and are available above Wakulla County's average wage and the % of products that will be distributed outside of the Triumph Gulf Coast area.

(ii) the amount and identity of other sources of funds for the proposed project or program;

The land owner/developer, NG Wade, will build-to-suit on 4.5 acres a 50,000 square foot facility at a cost of \$3.5 million to be leased to Project Gamestop. The company will invest \$2,840,773 in fixed assets (equipment). The County will prioritize this application to Triumph Gulf Coast and utilize the funds to support the cost of the company's fixed assets.

(iii) the location of the project or program;

Project Gamestop will be located just west of Opportunity Park tenant CSG Systems, Inc. on 4.5 acres in a BTS 50,000 sf facility. Opportunity Park is located on Hwy 363 (Woodville Hwy) in northeast Wakulla County.



(iv) summary description of the proposed program, including how the program will be transformational and promote economic recovery, diversification, and enhancement of the disproportionately affected counties,

Project Gamestop will be the first major manufacturer to establish in Wakulla County since Residential Elevators and St. Marks Powder, A General Dynamics Company, established here decades ago. While Wakulla has one of the lowest unemployment rates in the state, many of our residents would rather work closer to home and this project gives people a chance to do just that with a company on the cutting edge of its industry. A report generated by JobsEQ by Chmura shows the economic impact of the project to be

An infusion of 29 jobs at an annual economic impact on the local economy of \$11 million, including new to Wakulla payroll of \$1.8 million circulating through the economy is transformational to a county where 80% of the land is not developable. Expanding this company in Wakulla expands the competitiveness of Florida's Gulf counties by adding production to the development and corporate HQ elements and expanding sales to other states.

(v) a summary timeline for the proposed project or program.

The Company has expressed a desire to be operational within 16 months. The Wakulla BOCC will hear this item on June 7 at which time we are seeking project prioritization within approved Wakulla TGC applications as well as approval to submit the Pre-Application followed by the full application. Given the meeting timeframe of the TGC Board and the typical project review cycle of 3 times per project, we plan to run the PUD exception agenda item through the BOCC in concurrence with the TGC application review cycle with plans to proceed once we receive both approvals which should be around September or October 2021. All Phase I ESA work has been completed for Opportunity Park, so that will not be a timeline item. Extension of natural gas can occur concurrently with the facility construction.
