Project "Lightning Strike" is a key Supplier to a number of large investor-owned utilities throughout the U.S. "Lightning Strike" designs and manufactures electrical distribution transformers and transformer component parts. The product line offering of electrical transformers includes both single phase pole and pad mounted units, vaults for underground applications in urban areas, and three phase pad mounted units primarily used in light commercial applications. "Lightning Strike" is preparing to open a new manufacturing operation that will produce single phase pole mounted transformers. "Lightning Strike" is considering this move because the labor resources available at its current location simply cannot meet the current requirements of its manufacturing operations. The age and layout of their current facility also limits capacity. The Company has experienced double-digit growth over the past 8 years, but has tapped out the potential of its current resources and must look at expansion to continue to grow the business and even service its current customers. The \$7.0M Triumph grant will be used towards the purchase of equipment for the manufacturing operation.

"Lightning Strike" plans to relocate product line manufacturing to FL in stages, with the first phase being a pole transformer manufacturing facility included in this proposal. Based on its own research and conversations to date with Bay EDA, the Company believes the labor market in NW FL will address the staffing issues it is currently facing and allow for additional overall production capacity. Once this initial move is completed and functioning, "Lightning Strike" believes there are other business opportunities to immediately pursue which include another facility for 3-phase manufacturing and possibly even a pad producing plant if housing starts which drives the market remains strong.

"Lightning Strike" will have 5 to 10 employees relocate with the company and intends on hiring 75 to 80 personnel from the local community to operate the manufacturing plant with average annual compensation of \$60,000 by the end of Q2 2023. 175 jobs will be created by the end of 2025. These positions are plant manufacturing jobs including Welders, Coil Winders, Multi-Craft Maintenance Professionals, Metal Fabricators, Painters, Quality Assurance Technicians, Assemblers, and Laborers. There will also be supervisory positions for Production, Shipping/Receiving, and Maintenance. Finally, there will be some office positions in HR, Accounting, Engineering, and IT. The company provides an excellent health insurance benefit, 401(k) plan, paid vacation and holidays. "Lightning Strike" intends on being one of the most sought-after companies to work for in the Panama City Beach, FL community.

Below is a list of some of the attributes and further description of their business:

- 1. Finished goods transformers are stored outside on the "yard". They maintain safety stock for their larger customers ready to be shipped for emergency situations.
- 2. The company will work with the community sometimes taking on interns and we support our local schools, colleges and universities.
- 3. Noise is minimal.
- 4. From the community, they would require highly qualified candidates in Business and Engineering, and may include master's degrees, bachelor's degrees, or highly skilled HS graduates.
- 5. Employees must pass a criminal background check to qualify for employment.
