Program Administrator Report Triumph Gulf Coast Board Meeting September 13, 2021

The Triumph Gulf Coast staff continues regular work with grantees on the implementation of 38 active projects, with four projects completed, totaling over \$266,800,000. Staff monitors and reviews projects for compliance and processes requests for funds on an ongoing basis, and continues to work with applicants and potential applicants, to review pre-applications, applications and to negotiate agreements.

The 2020-2021 Auditor General's audit is ongoing.

Pre-Applications

As of Friday, September 3, 2021 Triumph Gulf Coast had received 257 Pre-Applications totaling over \$1,887,042,000 in requests. Five Pre-Applications were received between July 19, 2021 and September 3, 2021.

Staff recommends Pre-Applications 256 - 259 as eligible and 255 as ineligible.
