Brief Description of Individual/Entity/Organization: Northwest Florida State College is an open-door, open-access institution committed to serving all members of the community and infusing local industry with high-quality employees equipped with high-demand, relevant skills. The College provides robust academic services to prepare students for coursework and to guide them toward success. As part of Florida's public system of 28 state and community colleges, Northwest Florida State College offers bachelor's degrees, associate degrees, and certificates. The College's primary service district is Okaloosa and Walton Counties. The College operates seven campuses and centers. In addition to the flagship Niceville Campus, the College operates a joint campus with the University of West Florida in Fort Walton Beach and five educational centers: Chautauqua Center in DeFuniak Springs, Robert L. F. Sikes Education Center in Crestview, the Aviation Center of Excellence at Robert Sikes Airport in Crestview, South Walton Center in Santa Rosa Beach, and Hurlburt Field Center on Hurlburt Field. Annual enrollment is 8,054, which includes 7,054 students pursuing college credit and 1,000 students taking non-credit coursework.

Proposed Program and Anticipated Outcomes

Northwest Florida State College proposes an expansion of its award-winning Collegiate High School and dual enrollment programming to incorporate innovative workforce and career education aligned with high-demand industries and leading toward increased employability of students after graduation. Career Acceleration Pathways for Early College Students is comprehensive programming targeting dual enrollment students that seeks to increase the proportion of Okaloosa and Walton County high school students who successfully receive a high school diploma concurrently with an A.A. or A.S. degree—each with one or more CAPE-eligible certifications embedded in the program of study. Program activities include the following: (1) Addition of 9th grade to Collegiate High School (CHS), (2) Expansion of CHS program tracks from one to three—A.A., A.S., and Virtual Early College Academy, each which includes a CAPE certification, (3) Revised CHS programming enhanced with CTE pathways embedded in annual program activities and CHS Capstone, a seminar project completed at the culmination of the program, generating increased awareness of career opportunities in high-wage, high-demand fields, (4) Robust summer programming to include "NWF Futures Forward" with intensive CTE summer workshops with free opportunities for secondary students to explore CTE career pathways in immersive, hands-on experiences, (5) New "CTE Summer Institute" with accelerated paths for dual enrollment students to participate in fast-track summer classes to earn associate degree and certification-applicable training, (6) New "CTE Innovation Fair" incorporating business and community partners, (7) New "Early-Bird Dual Enrollment Program" with early a.m. instructional blocks designed for dual enrollment cohorts to participate in Aviation, Welding, Cybersecurity, or Advanced Technology and Engineering programs to precede the high school schedule at their home institution, and (8) Establishment of the Virtual Early College Academy which provides CHS and dual enrollment students with access to a hybrid college program with General Education courses taken fully online through NWF Online with technical core and elective courses taken through traditional, on-site College offerings in A.S. programs.

During the 6-year program, we anticipate serving 2,210 early college students with a minimum of 255 students graduating with their high school diploma, their associate's degree (A.A. or A.S.), and an industry certification each year.

Funding

Total project cost is projected to be \$29,014,707. The College requests \$10,267,474 from Triumph Gulf Coast (35.4%) with match provided by NWFSC for \$3,657,185 (12.6%) and the Florida Department of Education for \$15,090,048 (52%).

Location of the Program

The primary location for the Career Acceleration Pathways for Early College Students activities and support will be the NWFSC Collegiate High School, Raider Central (one-stop location for student services and K-12 Partnerships Division in Academic Affairs), and the Zogbhy Learning Commons (academic support, learning resources, and testing services). All curricular and extracurricular activities in support of the program will be conducted at the Niceville campus, virtually through NWF Online for online course elements, and at various NWFSC centers that house specialized program faculty and facilities supporting A.S. and CAPE certification programming.

Summary Description of the Program

The program leverages the College's established, award-winning Collegiate High School and thriving K-12 Partnerships and Career Education divisions as a catalyst to significantly increase the proportion of Okaloosa and Walton County dual enrollment students who earn their high school diploma concurrently with an A.A. or A.S. degree *with* a CAPE certification. Although dual enrollment students primarily earn A.A. degrees at present, the College seeks to expand the pipeline of dual enrollment students receiving A.S. degrees and industry certifications leading toward high-wage, high-demand jobs leading toward family-sustainable wages. This program targets a growing dual enrollment population, addresses a pressing need for a ninth-grade addition to Collegiate High School to eliminate a gap year for local STEM middle school students who plan to attend CHS in 10th grade, and accelerates credit achievement toward college degrees while students are in high school, which reduces the cost of college and shortens—or eliminates—students' time-to-degree after high school.

Dual enrollment programs provide affordable access to college programs for students across a variety of socioeconomic backgrounds, diversifying the institution's student demographics and supporting equity in educational opportunities. By increasing students' employability after graduation with industry certifications and associate degrees in hand, the program increases the proportion of high school graduates who are workforce-ready, promoting economic recovery and enriching the workforce with highly qualified, employable individuals across the disproportionately affected counties.
