## FIRST AMENDMENT TO GRANT AWARD AGREEMENT

  - "(ii) if any event or condition has arisen that could reasonably be expected to render the timely purchase and renovation of the Property as contemplated in the Grant Application by December 31, 2026 infeasible, impracticable, or illegal,"
- 2. Amendment to Section 5.1. The definition of "Completion Deadline" as set forth in Section 5.1 of the Agreement is hereby changed to "December 31, 2026."
- 3. Amendment to Budget. The Budget attached as Exhibit "B" to the Agreement is hereby deleted and replaced with the Budget attached hereto as Exhibit "B" and incorporated herein. All references to the Budget in the Agreement shall hereafter mean and refer to the Budget attached hereto as Exhibit "B."
- 4. **No Other Amendments.** Except as expressly provided above, the Agreement shall remain unmodified and in full force and effect.
