#### **SUMMARY**

#### OF

#### SECOND AMENDMENT TO

#### GRANT AWARD AGREEMENT

#### BETWEEN

#### TRIUMPH GULF COAST, INC.

#### AND

#### WAKULLA COUNTY SCHOOL BOARD (Project #198)

This summarizes the basic terms of a Second Amendment to Grant Award Agreement (the "Amendment") that has been negotiated between the staffs of Triumph Gulf Coast, Inc. ("Triumph") and Wakulla County School Board ("WCSB") under the Triumph Gulf Coast Trust Fund with respect to that certain Grant Award Agreement by and between Triumph and Wakulla dated October 21, 2019, as amended by that certain First Amendment to Grant Award Agreement dated February 24, 2021 (as amended, the "Agreement"). This summary is intended for notice purposes only and does not create any binding obligations on Triumph or WCSB with respect to (i) any amendments to the Agreement, or (ii) engaging in any further discussions or negotiations with respect to any amendments to the Agreement. The final terms and conditions of any amendment will be contained in the definitive Amendment approved by the Board of Directors of Triumph and WCSB and executed by Triumph and WCSB.

# ADDITIONAL GRANT FUNDS:

The total amount of the Grant is increasing by \$330,000, from \$1,780,000 to \$2,110,000, which additional funds shall be allocated to the Budget category of Salaries.

AMENDMENT TO BUDGET CATEGORY

In order to increase the Budget category of Salaries from \$600,000 to \$930,000, Section 4.1(a) of the Agreement is hereby deleted and replaced in its entirety with the following:

"(a) "\$930,000 of the Grant funds shall be allocated for Salaries, to be funded in the amounts and at the times as set forth in the Budget;"

#### OTHER REFERENCES TO GRANT AMOUNT

All references in the Agreement to the prior Grant amount are changed to \$2,110,000

#### INCREASE IN MATCHING FUNDS

Grantee's Matching Fuds shall be increased by \$330,000, from \$327,135 to \$627, 135. Accordingly, the first sentence of Section 5.2 of the Agreement is hereby amended to read in its entirety as follows:

"The total cost of the Project is \$2,767,135, of which (i) WCSB shall pay \$657,135 as shown in the Budget (collectively, the "**Matching Funds**"), and (ii) \$2,110,000 shall be provided by the Grant."

#### CHANGE IN PERFORMANCE METRICS:

The Performance Metrics are being amended to require an additional 100 certificates to be earned by middle schoolers that prepare them for higher level VSO and UAS certificates. Accordingly, Section 8.3(a) of the Agreement are hereby amended to read in its entirety as follows:

"(a) **Performance Metric #1:** (i) By December 31, 2026, not less than 175 students will have obtained industry-recognized certificates in Visual Sight Operation (VSO) and not less than 175 students will have obtained industry-recognized certificates in Unmanned Aircraft Systems (UAS), and (ii) by June 30, 2027 100 certificates will be earned by middle schoolers that prepare them for higher level VSO and UAS certificates."

DELETION OF BUSINESS DONATION PROVISIONS:

As previously agreed to by Triumph for WCSB and other grant recipients, the Business Donation requirements under the Agreement are being deleted.

#### AMENDMENTS TO EXHIBITS:

The form of Application for Disbursement attached to the Agreement as Exhibit "A" is being deleted and replaced with the form of Request for Funding attached hereto as Exhibit "A", and all references in the Agreement to an Application for Disbursement shall hereafter mean and refer to a Request for Funding. The Budget attached to the Agreement as Exhibit "B" is being deleted and replaced with the form of Budget attached hereto as Exhibit "B", and all references in the Budget shall hereafter mean and refer to the Budget shall hereafter mean and refer to the Budget attached hereto.

### OTHER TERMS AND CONDITIONS:

This is a summary only. The Amendment terms and conditions as agreed to by Triumph and WCSB.

(d) WCSB made no misrepresentation or omission of a material nature in the Grant Application, or any supplement or amendment to the Grant Application, or with respect to any document or data furnished with the Grant Application or pursuant to the Agreement;

(h) WCSB is not in material violation, default, or breach of or under any provision of the Agreement;

(j) WCSB is not in breach of any representation or warranty contained in the Agreement;

(k) No federal, state, or local agency (including WCSB) providing financial assistance to the Project has revoked, suspended, or terminated that financial assistance to the Project, including, but not limited to, the Matching Funds;
