Executive Summary: Code Name: Project Tachyon Industry: E-mobility Manufacturing, Location: Panama City, Bay County Project estimated investment: \$22.8M Job Creation: 209 by October 1 of 2024, with average annual compensation estimated at \$55,000+ versus Bay County average of \$44,209.

Project "Tachyon" is a German manufacturer of E-mobility solutions. Tachyon is a key supplier to a number of large customers located throughout the world. Their main products include electric vehicle batteries and electric charging stations. These are critical to meet the demands of a growing Electric Vehicle (EV) industry. The company has customers in the U.S. and will be establishing a manufacturing/headquarter operation to service these existing clients. Due to the sense of urgency to get into operation in the United States, the company is looking to purchase an existing 50,000 square foot facility in Panama City, Florida. This building is located on a 9 acre site that also has a "pad-ready" additional 50,000 square foot expansion footprint adjacent to the existing facility. The \$5.25M Triumph grant will be used towards the purchase of the property/building. The facility will be owned by the Bay County Commission and leased back to the company at an economic development lease rate. The company will have the option to purchase the facility at the end of the 10-year lease period.

"Tachyon" will hire 209 employees by 2024. The positions will be electrical engineers, industrial engineers, first line supervisors, electrical technicians, truck operators, freight and stock laborers, general management, industrial production managers, financial manager, human resource manager, information systems specialists, logisticians, bookkeeping/accounting specialists, production/planning managers, shipping/receiving/inventory manager. The company plans to pay above the 115% of the average wage of Bay County, Florida. They also plan to offer a competitive benefits plan to all employees.

The total capital investment for this project is \$22.8M. We are seeking \$5.25M from the Triumph Gulf Coast Fund to support the purchase of the facility. The company will be investing \$10.8M in machinery, equipment, testing tools and racking for the warehouse.
