RE: Triumph Gulf Coast, Inc. Semi-Annual Report January 2022 – June 2022

Dear Governor DeSantis, President Passidomo, and Speaker Renner:

Triumph Gulf Coast, Inc. was originally created in statute in 2013 and received its first funding from the Deepwater Horizon Oil Spill Settlement in 2017. In the ensuing years, Triumph Gulf Coast has become one of the most successful and effective economic development engines in Florida history. As the stewards of \$1.5 billion awarded to Florida by the federal court for economic damages caused by the oil spill, Triumph Gulf Coast's statutory mission is to strengthen and diversify the economy of coastal Northwest Florida through job creation, workforce development, and public infrastructure.

Since its first grant award of \$10 million in 2018 to expand the Port of Panama City, Triumph has awarded more than \$389 million to 54 projects in all eight counties disproportionately affected by the Deepwater Horizon Oil Spill. Because of its vetting and selecting of well-conceived projects, attracting 2+ to 1 matching funds, and requiring strict performance contracts with enforceable clawbacks, Triumph was described as "...a model of efficiency and



effectiveness...." by the James Madison Institute. (See attached Fox Business News Editorial by Bob McClure, President and CEO, James Madison Institute, published on May 18, 2020.)

The highly respected business and governmental economist, Dr. Rick Harper, reports that every \$1 awarded by Triumph is creating \$18.8 in beneficial economic growth for Northwest Florida, an extraordinary return on investment.

With merely a third of Triumph's total corpus committed and approximately \$1 billion remaining to be awarded, Triumph's milestones to date already include:

- More than \$225.5 million in infrastructure investments including expansions of two seaports, a major bypass to support military missions, a maritime industrial park making possible as much as \$10.3 billion in Coast Guard construction, outside the gate airfield expansion to substantially expand Naval support missions, three industrial parks across the Highways 90 and 10 corridors with a majority of sites already committed. Job creation projects include an aircraft maintenance-repair-overhaul campus with international partners and customers, electrical transformer manufacturing, pharmaceutical and medical device manufacturing, marine manufacturing, and multiple logistics and distribution facilities.
- \$136.5 million in education workforce training including facilities and faculty for airframe, aircraft maintenance and pilot training, a joint venture with the University of Florida and a local school district for artificial intelligence instruction, a Florida State University STEM lab school supporting the post-Michael rebuild of Tyndall Air Force Base, four Unmanned Systems drone training programs linked to K-12 school districts, a nurse training program that will add 4000 new nurses and provide \$300 million of additional household income to the Triumph region within the next 10 years, Career Technical Education (CTE) training in welding, pipefitting, carpentry, construction and industrial trades, HVAC, agriculture sciences, emergency management, fire sciences, health care services, information technology, commercial driving licenses, and engineering/design sponsored by seven K-12 districts, two universities, four state colleges, and a county sheriff's office.
- \$8 million in Triumph-sponsored research to restore the aquaculture of Florida's legendary Apalachicola oyster beds. This funding has induced federal and state research grants of over \$20 million.
- Nearly \$12 million in Triumph-funded equipment housed in the brand-new, state-of-theart IHMC Center for Human Healthspan, Resilience, and Performance research facility at the Institute of Human and Machine Cognition in Pensacola. This equipment will allow IHMC to attract no less than \$35 million in competitively awarded research grants to our region.
- \$19 million in ad valorem tax benefits to assist local governments in covering emergency post-hurricane costs and support counties in attracting private job-creation industry.



Of the more than \$136.5 million in education and workforce training, more than \$41 million is in programs with a primary focus in cybersecurity and IT training with education partners for Northwest Florida residents, active-duty military families, and separating uniformed military to qualify them for high-skill, high-wage jobs in Northwest Florida.

The net effects of those milestones include:

- 5,700 net new jobs, with all incentivized jobs paying 115% or more of the prevailing wages in the area
- 38,714 national industry certifications or milestones earned by K-12, college, and university, retiring military and military spouses in the very occupational categories most needed in our coastal economy
- More than \$600 million in net new family income annually
- Uncommon risk-sharing by attracting almost \$861 million in matching funds, attracting private and public sector partners as full investors in every project
- A regional economy more diversified, resilient, and self-reliant than at any other time in our area's history

A highly unusual feature of Triumph's operation is the strict, objective, measurable performance metrics applied to every project. Binding contracts with qualified applicants and partners ensure that Triumph can reclaim funds in all cases if metrics aren't achieved. When hurricanes and pandemic conditions justified flexibility, the Triumph board renegotiated with a few applicants. But, to date, not one of the funded projects has been cited for non-performance nor have any funds had to be clawed back.

Triumph has provided extensive hands-on help to applicants to qualify for funding, evaluated every proposal with due diligence, return on investment, and job-creation viability prior to every award, and managed and monitored every project for contract compliance and faithful performance. These functions are carried out by Executive Director Susan Skelton, Program Administrator Cori Henderson, Economic Advisor Dr. Rick Harper, Education/Workforce Advisor Dr. Frank Fuller, and Construction Compliance Advisor Randy Lewis, AIA, together with the accounting firm of Tipton, Marler, Garner and Chastain, and the Clark Partington law firm.

Total operational costs – including financial management, legal services, and research – have cost less than 3/4 of 1 percent of Triumph funds, a nearly unprecedented record for low overhead and financial stewardship. The 2022 legislative session agreed that \$5 million of interest earned by Triumph on its unexpended funds could be used for the ever-growing project management and compliance over the remaining 11 years of the organization's intended life.



Triumph Gulf Coast is independently audited by outside auditors and is examined and audited annually by the Auditor General of Florida. Not once in its existence has Triumph been cited or criticized by any auditor or oversight body.

Last spring Triumph Gulf Coast's original directors completed their terms, which, by law, cannot be extended. Directors who have served since the organization's inception, and their appointing authorities, are:

In coronavirus crisis lessons for recovery from the Gulf Coast's Deepwater Horizon disaster



Last month a ten-year anniversary passed with little notice. On April 20, 2010, the Deepwater Horizon offshore <u>oil platform</u> suffered an explosion that resulted in the largest marine oil spill in history.

Over the next several weeks, close to five million barrels (approximately 210 million gallons) of oil seeped out into the Gulf of Mexico.

The consequences of the event are largely considered the greatest environmental

catastrophe in U.S. history and an <u>economic disaster</u> for the communities along the panhandle of Florida through Alabama and Mississippi.

Economically, the cost to the Gulf coast was estimated in the tens of billions of dollars.

There is an important lesson from that disaster that could offer a novel approach to the economic challenges ahead of us today.

In response to the Deepwater Horizon crisis, the State of Florida established Triumph Gulf Coast, Inc. – a nonprofit designed solely to administer Florida's portion of the relief funds.

The Triumph board was appointed by elected leaders at the state level to oversee the collection and distribution of funds for the recovery, diversification, and enhancement of the eight Florida counties impacted.

In the years since its formation, Triumph Gulf Coast has distributed close to \$250 million in relief directly to affected businesses and communities – and has done so as a model of efficiency and effectiveness.

In response to the COVID-19 economic lockdowns established in almost all states, our national economy has gone from a Ferrari to a seized engine in just a few short weeks.

The national unemployment rate of 3.5 percent (a 50-year low) jumped to 4.4 percent in March and then 14.7 percent in April, meaning 20.5 million Americans lost their jobs in April alone.

The economic fall-out is prompting discussions about a "Great Depression 2.0" by summer. And the federal government, seeking to do whatever it can to design relief packages, is proving once again to be as inefficient, ineffective, and special-interest-pandering as its 11 percent approval rating would suggest.

We've added more than \$2 trillion to our national debt, and the trajectory has us on course to spend another \$2 trillion before the year is out.

The next phase of economic relief may well include up to \$500 billion to states to help address revenue shortfalls. More direct relief to businesses and individuals may also be in the future.

Those boards should possess the authority and accountability to determine the most

valuable methods, channels, and strategies for using federal aid dollars.

While many conservatives may question the merits of more federal debt in the form of cash to states, the reality is there is zero chance Congress won't authorize more spending.

Let's ensure the money is spent in a way that maximizes value and targets direct and specific needs. Let's face it -- each state is unique – in demographics, governing structures, and economic conditions.

The best use of \$5 billion dollars will look quite different in New York than it will in New Mexico. How a small business grant program works in Colorado should probably be structured and function differently than it would in Connecticut.

In a state like Illinois, with substantial fiscal challenges, CARES Act funds may need to be allocated to social programs in urban centers more than in a state like New Hampshire, which doesn't have the same fiscal conditions.

As we confront this fiscal shock, our leaders should apply the lessons from Deepwater. Adopting the approach Florida took 10 years ago to combat a previous crisis, we can ensure that future relief monies are used in the best possible manner, while minimizing inefficiencies and the fraud or misuse that the federal government can't seem to eliminate (we're looking at you Kennedy Center).

Between now and the end of May, each state should work to establish its own "COVID-19 Economic Recovery Inc" nonprofit, with a board made up of a cross-section of policymakers, local officials, business leaders, and community stakeholders.

Some may make the case, not unreasonably, that the state legislature should control this money, since they are elected by the people to create a budget and this is part of that function. But in many states, public-private partnerships have proven to be of tremendous value in addressing specific challenges.

The concept of mobilizing the business community, in concert with partners in state and local government and community leaders, has the potential to not only ensure that future relief funds are channeled in the most valuable manner, but also to generate new avenues for resources.

Throughout our 233-year history as a constitutional republic, citizens have shown up when called. Let the states tap into their resources to make the economic recovery as

powerful as it can be.

2022 Review of Annual Grant Award Reports

Northwest Florida, like the rest of the state and nation, faced new labor and supply chain shortages in 2022 due to unprecedented impacts to the global economy. Despite these challenges, Grantees continue to implement projects and programs and Triumph Gulf Coast continues to execute new grant awards that will yield long term economic transformation for the region.

As of this month, Triumph Gulf Coast has executed 53 grants totaling over \$388,000,000 and is managing 44 active grants. In order to meet statutory compliance requirements, Triumph staff monitors, reviews and processes requests for funds on an ongoing basis.

Staff recommends the Board accept a recommendation to continue to fund the following grants:

29 Wakulla School Board, Career and Technical Education – PROJECT COMPLETED

Triumph Grant Award - \$3,926,867 Grantee Match - \$375,000 Total Project Cost- \$4,301,867

The Digital Tools K-8 components of the project significantly exceeded expectations and the required number of industry certifications to be earned. The Automotive Repair and HVAC program have met 100% of the required industry certifications. More than 1200 of 410 required certifications were earned.

Construction of a new bus barn to allow for the addition of new classrooms and lab space for the career and technical education program has been completed.

43 Okaloosa County, U.S. Highway 90 Water & Sewer Extension

Triumph Grant Award - \$1,500,000 Grantee Match - \$2,703,171 Total Project Cost- \$4,203,171

Construction broke ground in July of 2020 on 4.3 miles of water and sewer line construction on U.S. Highway 90 to the Shoal River Ranch industrial gigasite site. Due to COVID-19 related labor shortages, the County requested and was granted an amendment that extended the date of project completion. **Construction was completed in June 2021 under budget.**

The County requested and was granted an amendment in May 2022 to use remaining Triumph funds to extend the water and sewer lines an additional 2,500 feet to reach two County-owned parcels at the

gigasite. The County was also awarded a \$3.2M Jobs Growth Grant Fund in May 2022 for road and additional site work at the Shoal River Ranch site.

The Economic Development team continues to market the site and work with interested parties. They are currently negotiating a letter of intent from a US-based company for a manufacturing project that is anticipated to satisfy the agreement's metrics.

46 Okaloosa County, Southwestern Crestview Bypass

Triumph Grant Award - \$64,100,000 Grantee Match -\$134,919,000 Total Project Cost- \$199,019,000

The project design is 100% complete, all right-of-way has been acquired and the project is fully permitted. Due to COVID-19 suspension of field visits by FDEP and the Army Corps of Engineers, the project's permitting timeline was delayed. The County requested, and was granted, an amendment from Triumph that extended the date of project completion due to COVID-19 related delays. The project is now on schedule and construction is underway.

The metric for this project is the creation of 1300 new jobs in the EMSI Sector 901200: Federal Government, Military, in addition to 243 new jobs projected to be created in the sector by 2029. The sector also includes private sector defense contractors.

According to EMSI, this sector now employs 18,234 individuals in Okaloosa County, a total of 2,182 new Okaloosa County jobs in EMSI Sector 901200 since the Triumph performance period began in 2019. Satisfaction of the performance metric will be determined in 2029.

49 Port Panama City, Eastern Terminal Expansion

Triumph Grant Award - \$10,000,000 Grantee Match -\$52,064,000 Total Project Cost- \$62,064,000

Triumph's first project was the expansion of Port Panama City's Eastern Terminal. Construction was completed at the end of 2020. The Port remains focused on continued business recovery and growth following Hurricane Michael and revised growth projections due to COVID-19 impacts on the economy.

The Port recorded a record year for new cargo activity in 2022, with cargo tons increasing four percent year-over-year to a total of 2,030,424 tons handled between the two facilities. FY2022 was another record year for revenues for the Port which recorded revenues of more than \$19 million. Revenues increased 9 percent over FY2021's record revenue. Due to the growth in cargo activity, the Port surpassed its goal of \$18 million in annual revenues by March 2025 with additional growth expected in 2023. The project's final metrics will be submitted in early 2023.

72 Santa Rosa County, Whiting Aviation Park Site Readiness

Triumph Grant Award - \$8,523,655 Grantee Match - \$3,094,720 Total Project Cost- \$11,618,375

Infrastructure improvements to Whiting Aviation Park began in May 2020 and were **completed on budget at end of 2021.**

With Leonardo Helicopter's commitment to opening a helicopter support center at the Aviation Park, Santa Rosa is on track to meet its performance metric requirements.

98 Walton County Sheriff Office, Vocational and Technical Training Program

Triumph Grant Award – \$2,417,965 Grantee Match - \$2,433,600 Total Project Cost- \$4,851,565

The Walton County Sheriff Office partnered with Emerald Coast Technical College on this Triumph grant to expand Sheriff Michael Adkinson's vision to "build better people" through inmate job training programs. Students are earning credits toward Welding, HVAC, Heavy Equipment Operator industry certifications and Commercial Driver Licenses (CDL) among others. Currently, 321 of 562 certifications have been completed and the project is on track.

COVID-19 and Hurricane recovery related construction cost increases for the Emerald Coast Technical College portion of the project led to an amendment to the agreement in June of 2021.

120 City of Pensacola, Pensacola Airport Infrastructure

Triumph Grant Award - \$66,000,000 Grantee Match - \$268,825,000 Total Project Cost- \$334,825,000

In January of 2020, the City of Pensacola secured the final financial commitment for the project with a Governor's Job Growth Grant Fund award. In 2021, Triumph granted an amendment to the project that allowed a redesign and additional time for Triumph funded hangars 3 and 4, the support services center and administrative office space. The amendment was requested due to increased construction costs associated with Hurricane Sally and the reduced availability of labor and materials due to COVID 19.

The project continues to be on track based on the new timeline with construction of the Triumph funded items expected to break ground in early 2023 with completion anticipated in 2025.

143 Bay District Schools, Haney HVAC Program

Triumph Grant Award - \$847,955 Grantee Match - \$58,400 Total Project Cost- \$906,355

The program has seen steady enrollment and students are receiving instruction in the newly renovated HVAC lab funded by the Triumph grant. Following Hurricane Michael, in 2019 the grant was amended due to increased construction costs. The project is on schedule with 633 of 815 certifications completed.

148 Gulf Schools District, Agri-Science Expansion

Triumph Grant Award – \$125,000 Grantee Match - \$165,000 Total Project Cost- \$290,000

COVID-19 school closures had an impact on the number of students who participated in the program during the 2020 school year, however, enrollment significantly increased in 2021 and 2022. Plans are underway to integrate unmanned systems into the program. Currently student have completed 10 of 90 certifications.

153 Gulf School District, Unmanned Systems

Triumph Grant Award – \$750,000 Grantee Match - \$652,000 Total Project Cost- \$1,402,000

After COVID-19 school closures slowed the start of this program, High School and Middle School students across Gulf County enrolled in the program, earning certifications and their FAA UAS Pilot licenses. Multiple students are using their licenses locally for employment. Students have currently completed 36 of 525 certifications.

Students from Port St. Joe High School won the Triumph Gold Cup Drone Competition/Forgotten Coast Drone Rodeo competing against and Wewahitchka High School and Franklin Schools students.

157 Franklin County School Board, Phase 1

Triumph Grant Award – \$2,327,322 Grantee Match - \$984,500 Total Project Cost- \$3,311,822

This project provided funds for welding, nursing and digital tools industry certifications. The new welding facility funded by the project opened in early 2021 and students are gaining certifications in it. 802 of 777 certifications were earned. Welding students dually enrolled in college classes with Lively Technical College for the 2022-2023 school year.

An amendment was requested in May 2022 to extend the timeline for construction of the ABC School computer lab due to Hurricane Michael and COVID-19 delays. Construction is expected to break ground in 2023.

180 Gulf School District, WHS Welding Program

Triumph Grant Award - \$250,000 Grantee Match - \$494,282 Total Project Cost- \$744,282

This new welding program requires 335 hrs of instruction prior to students taking the first certification exam. Delays including COVID-19 and tropical weather school closures contributed to a slow start for the students. Enrollment in the program has significantly increased. 14 of 50 industry certifications have been earned including the first of NCCER Welding 2 certifications ever in Gulf District Schools.

Through a collaboration with Eastern Shipbuilding Group (ESG) and the Bay County Artificial Reef Association (BCRA), Wewahitchka High School welding students are constructing artificial reefs to the specks of BDRA with materials provided by ESG. The reefs will be deployed in local waters.

185 City of Panama City / Eastern Shipbuilding Group (ESG) Infrastructure Improvements

Triumph Grant Award - \$20,000,000 Grantee Match - \$50,380,000 Total Project Cost- \$70,380,000

Project components funded by Triumph are currently in various stages of bidding and construction. In 2020 Triumph approved a timeline extension amendment due to COVID-19. In 2021 Triumph approved an amendment that re-allocated budgeted match dollars which reduced the amount of funds provided by public sources and increased the amount to be provided by the private partner Eastern Shipbuilding (ESG).

ESG is currently in the process of constructing OPC's #1, #2, #3 and #4. Construction is currently on schedule and delivery of OPC #1 is expected in 2023. ESG submitted its FPR (Final Proposal Revision) to the USCG for Stage 2 of the OPC Program and the USCG awarded that portion to Austal USA. ESG protested the decision with GAO. ESG eventually withdrew its protest with GAO due to the USCG's unwillingness to disclose critical information to ESG's attorneys under protective order. ESG recently filed suit in the Court of Federal Claims, where it is continuing to pursue the protest of the award to Austal USA.

ESG continues to execute for its customer on the OPC project for Hulls 1-4. This project, along with ESG's commercial business, continues to grow and as does the workforce to support it. ESG continues to recruit employees to the community to support its commercial and government business.

Triumph conducted an informal audit of the systems ESG is utilizing to track the performance metrics required to be met under the Triumph agreement, as well as the current progress towards achieving the performance metrics. The Triumph team gained additional comfort that ESG's approach to tracking performance metrics was sound with more than the 900 required jobs filled.

187 Northwest Florida State College, Walton Works

Triumph Grant Award – \$2,763,716 Grantee Match - \$2,970,651 Total Project Cost- \$5,734,367

Following the completion of facility construction in early 2021, significant progress has been made on certificate attainment in Industrial Trades, Welding, HVAC, EMT/Paramedics, Fire Safety, Cyber Security and Unmanned Systems. 945 of 1,570 certifications have been completed. Courses are scheduled at times that allow dual enrollment students to participate.

190 Walton County, US Highway 331 Water and Sewer Extension

Triumph Grant Award - \$1,742,407 Grantee Match - \$3,000,000 Total Project Cost- \$4,742,407

In 2020, the County requested and was granted a Triumph Agreement extension due to COVID-19 impacts on the project's timeline. In August of 2021, due to the construction industry material and supply chain disruptions, the County issued a "Limited" Notice to Proceed to allow the Contractor to procure the long lead time materials prior to construction beginning December 2021. **Construction was completed in December 2022.**

With sewer and water soon to be available, the County and Economic Development Alliance have sold a 10 acre parcel of land to a manufacturing company and a 5 acre parcel to an unmanned aerial vehicle manufacturer interested in the proximity to Eglin Air Force Base. The jobs created at these businesses will be submitted towards the 100 new jobs metric for this project.

191 Franklin County, Apalachicola Airport

Triumph Grant Award - \$1,059,000 Grantee Match -\$1,225,000 Total Project Cost- \$2,284,0000

In 2021, Franklin County awarded a task order for the planning, design, bidding and construction phase services for the Fuel Farm Replacement Project at the Apalachicola Regional Airport. At this time, 100% of the design is complete. The project is anticipated to break ground in 2023.

198 Wakulla School Board, UAS/VSO Certifications

Triumph Grant Award – \$2,110,000 Grantee Match –\$657,135 Total Project Cost- \$2,767,135

The program began in January of 2019. However, due to COVID-19 school closures the classes were put on hold until the 2020 school year. In August of 2022, the grant was increased to expand the program to middle school students. 84 of 450 industry certifications have been completed at this time.

200 Franklin County School District, Phase 2 Unmanned Systems and EMT

Triumph Grant Award – \$1,215,000 Grantee Match -\$1,967,000 Total Project Cost- \$3,182,000

Phase 2 of the Franklin School District project originally included UAS/UAV, EMT/EMR and additional digital tools certifications. COVID-19 school closures and the resulting impact on the number of students returning to the classroom slowed the progress of the project. The District requested and Triumph executed an amendment in November 2021 to expand the certification offerings to include carpentry and to extend the project's end date.

The Unmanned Systems courses saw a significant increase in enrollment following the Triumph Gold Cup Drone Competition/Forgotten Coast Drone Rodeo between Franklin Schools and Gulf County's two High School teams. Students have currently attained 182 of 410 certifications.

202 Gulf Coast State College Gulf/Franklin Campus, Center for Emergency Response Communications

Triumph Grant Award – \$5,147,750 Grantee Match -\$4,877,285 Total Project Cost- \$10,025,035

Delays and quality of newly purchased equipment due to supply chain backlogs have resulted in projects delays. Due to demand across the eight counties to participate in the program, participants are training with the instructors as equipment arrives. 283 of the 763 certifications have been earned.

206 AMIkids Maritime Academy/PCMI Properties, Inc., Unmanned Systems and Construction Trades

Triumph Grant Award -\$ 1,737,500 Grantee Match -\$3,104,031 Total Project Cost- \$4,841,531

Executed in January of 2021, students began earning certifications during the Summer of 2021. The program trains students in aerospace, underwater robotics and underwater unmanned systems and construction. The Academy is working with FAMU to create a dual enrollment program in Underwater Robotics to take place at the Maritime Academy.

AMIkids Maritime Academy, the Bay County Sheriff, Career Source Gulf Coast and the Federal Department of Labor have entered into an agreement for the Triumph funded construction program to be expanded to the county jail where it will serve 16-24 year olds.

The project is on track with 56 of 1000 industry certifications completed following COVID-19 delays.

207 Gulf Coast State College Gulf/Franklin Campus, Nursing Simulation

Triumph Grant Award - \$2,200,358 Grantee Match -\$1,155,520 Total Project Cost- \$3,355,878

This project was executed in January of 2020. Following a number of construction-related delays, the College requested an amendment that Triumph granted in the fall of 2021 related to the renovations of new the Nursing Lab which is underway. Due to COVID-19 there were challenges gaining necessary clinical hours in this rural community and decreased enrollment.

Today the simulators are successfully being used in the Practical Nursing, LPN & AND courses. The CNA program is anticipated to restart in Spring 2023. Additional recruitment efforts are planned to encourage enrollment. 129 of 289 certifications have been completed.

209 Santa Rosa County, Project Lionheart - Northwest Florida Industrial Park at 1-10

Triumph Grant Award - \$3,484,728 Grantee Match -\$6,832,001 Total Project Cost- \$10,316,729

Granted in 2020, the project is progressing on budget and according to schedule. Construction of a road, retention pond and sewer improvements are underway. In 2021, Triumph granted an amendment to the project that increased the number of jobs required to meet the metric to 100 and reduced the average wage to 115% of the county's average.

Santa Rosa County has received letters of intent for all available 50 acres at the 1-10 Industrial Park. These company will satisfy the job creation metrics for the project.

210 Gulf Coast State College Gulf/Franklin Campus, UAS Pilot Boot Camp for Exiting Military

Triumph Grant Award – \$2,259,063 Grantee Match – \$1,745,937 Total Project Cost- \$4,005,000

The inaugural unmanned systems class took place during the summer of 2020 with strong enrollment and program interest. The project is currently ahead of anticipated certificate attainment goals with 576 of 700 certifications completed and graduates being recruited for immediate employment.

211 Pensacola State College, Logistics & Distribution: Ground Transportation

Triumph Grant Award – \$3,862,951 Grantee Match – \$7,478,850 Total Project Cost- \$11,341,801

Executed in May of 2021, the groundbreaking for the new training building funded by USEDA took place September 2021. The building was completed in August of 2022 and at this time 69 of 1000 CDL credentials have been earned.

213 Florida's Great Northwest, Education Research and Marketing Grant

Triumph Grant Award - \$733,000 Grantee Match - \$470,000 Total Project Cost- \$1,135,000

In March of 2020, Florida's Great Northwest (FGNW) executed a grant to perform labor supply and demand analysis and to market the workforce and infrastructure assets of the Triumph Region. FGNW subcontracted with the research firm ABLE Operations for the research and VisionFirst Advisors for the marketing campaign.

Dr. Aaron Schmerbeck with ABLE Operations presented the initial labor supply and demand analysis report to the Triumph board in early 2021 and FGNW published the report on its website. In 2022, Dr. Schmerbeck updated the report to include Cybersecurity and Unmanned Systems. VisionFirst Advisors created numerous marketing and promotional pieces about the Triumph Gulf Coast fund, including videos, photos, fact sheets, a white paper and social media posts in preparation for the campaign that kicked off in September 2021 that are successfully being used today to market the workforce and assets of the eight county Triumph region.

The grant was amended in August 2020 to provide additional funds to allow for extraction of industry certification data from the Florida Department of Education's education data warehouse. A contract between the Florida Education Foundation and FGNW is under review to begin this work. The data will be used to enhance the marketing of Northwest Florida's workforce to site location consultants and company decision makers.

215 Wakulla/Lively, A&P Expansion

Triumph Grant Award - \$3,250,000 Grantee Match - \$400,000 Total Project Cost- \$3,650,000

This project was executed in September of 2020 with students starting classes in August of 2021. The program is on track and at this time students have earned 70 of 300 certifications.

216 Northwest Florida State College, Aviation Center of Excellence

Triumph Grant Award – \$7,064,665 Grantee Match - \$7,303,253 Total Project Cost- \$14,367,918

This project was executed at the end of June of 2020 with A&P classes beginning in the fall of 2021. Classes are underway for A&P training and professional pilot flight training for adults and duel enrollment students. The program requires two years of instruction to sit for certification. The project is on track with 134 of 1255 certificates earned.

217 AMIkids Pensacola, Workforce Education

Triumph Grant Award - \$408,000 Grantee Match -\$647,918 Total Project Cost- \$1,055,918

This project was executed in September of 2020 and will result in NCCER OSHA, Core and Carpentry industry certificates. Students have earned 31 of 130 certifications. Staff turnover has been a challenge for the program in 2022.

221 Locklin Technical School, Hurricane Michael Fast Track Certifications - COMPLETED

Triumph Grant Award – \$182,000 Grantee Match – \$44,770 Total Project Cost- \$226,770

This project was executed June 30, 2020 and classes started immediately in July. The project is complete with 38 of 36 certifications earned.

222 Okaloosa Technical College, Hurricane Michael Fast Track Certifications - COMPLETED

Triumph Grant Award – \$200,000 Grantee Match - \$25,000 Total Project Cost- \$225,000

Executed in July 2020, this project is complete with 40 of 40 industry certifications earned.

223 Emerald Coast Technical College Hurricane Michael Fast Track Certifications - COMPLETED

Triumph Grant Award – \$200,000 Grantee Match - \$20,000 Total Project Cost- \$220,000

Executed in June of 2020, this project this project is complete with 40 of 40 industry certifications earned.

224 Wakulla County School Board/Lively Tech Hurricane Michael Fast Track Certifications - COMPLETED

Triumph Grant Award – \$200,000 Grantee Match -\$10,000 Total Project Cost- \$210,000

Executed in June of 2020, this project is complete with 40 of 40 industry certifications earned.

227 Port Panama City, Intermodal Distribution Center (IDC) Expansion

Triumph Grant Award - \$3,000,000 Grantee Match -\$6,487,967 Total Project Cost- \$9,487,967

Triumph awarded funds in the Fall of 2020 to create "pad-ready", rail-served sites zoned for heavy industry at the IDC. Construction broke ground in April 2022 with construction nearing completion at the end of 2022. The Port requested, and Triumph agreed to, an amendment in Summer 2022 to reallocate the budget among the project partners due to increased construction costs.

FedEx Ground announced construction of a 251,000 facility at the IDC earlier in this year. The Port continues to work with the Bay Economic Development Alliance to attract additional large manufacturing and distribution prospects to the site.

228 Pensacola State College, COVID-19 Infrastructure and Logistics Fast Track - COMPLETED

Triumph Grant Award – \$74,000 Grantee Match - \$182,518 Total Project Cost- \$256,518

Executed in July of 2020, this project is complete with 40 of 40 industry certifications earned.

229 Tallahassee Community College, COVID-19 Infrastructure and Logistics Fast Track - COMPLETED

Triumph Grant Award – \$276,500 Grantee Match – \$22,500 Total Project Cost- \$299,000

Executed in June of 2020, this project requested and received a time extension in the summer of 2021. The project has been completed with 20 industry certifications earned.

230 Walton County Schools, IT & Healthcare Certificate Program

Triumph Grant Award – \$3,846,000 Grantee Match – \$4,253,500 Total Project Cost- \$8,099,500

Executed in January of 2021, facilities are being constructed and renovated. Utilizing existing facilities student have earned 547 of 2,535 industry certifications.

233 Institute for Human & Machine Cognition (IHMC), Center for Human Healthspan, Resilience and Performance

Triumph Grant Award – \$11,968,119 Grantee Match – \$66,949,677 Total Project Cost- \$78,917,796

Executed in March of 2021, IHMC, a research institute of the Florida University System is conducting human performance and resilience related research and providing substantive assistance to facilitate the commercialization of the research funded by this program. As match for the Triumph grant, IHMC has been awarded \$10.2 million in competitively awarded external research grants and contracts for human performance and resilience related research.

IHMC requested and was granted an additional \$6 million dollars in November 2022 to equip a new human performance and resilience research facility. The additional Triumph grant funds will be matched by the building construction and an additional \$17 million in competitively awarded external research grants and contracts for human performance and resilience related research.

237 Port St. Joe Port Authority, Port Dredge

Triumph Grant Award - \$15,000,000 Grantee Match - \$41,308,646 Total Project Cost- \$56,308,646

In November of 2021, Triumph awarded the Port funds toward dredging, contingent on securing additional matching funds. The Port is still seeking additional funds to start the project.

240 Santa Rosa County, Santa Rosa Industrial Park East (SRIPE)

Triumph Grant Award - \$6,000,000 Grantee Match -\$22,136,149 Total Project Cost- \$28,136,149

Granted at the end of 2020, the Santa Rosa Industrial Park East infrastructure project is currently on budget and on schedule. Design work is almost complete with construction anticipated to be done by the end of 2024. The project will create at least 170 jobs in the logistics and distribution and manufacturing target sectors.

Letters of intent have been received by Santa Rosa for all available acreage at the park.

243 Okaloosa School District, AI Learning Institutes

Triumph Grant Award – \$2,840,000 Grantee Match – \$2,860,000 Total Project Cost- \$5,700,000

Executed at the end of July 2021, classes started during the 2022-2023 school year with 304 students enrolled at eight middle schools and one high school. This project will create elementary standards for 4th and 5th grade tied to the delivery of Artificial Intelligence (AI) curriculum, middle school curriculum frameworks for an Introduction to Artificial Intelligence course, a high school AI program and provide professional development for AI teachers.

The project will result in at least 1,100 industry certifications and is ahead of schedule.

246 Florida State University - Panama City, Cybersecurity and New Technologies

Triumph Grant Award - \$11,500,702 Grantee Match - \$11,500,702 Total Project Cost- \$23,001,404

Executed in October of 2021, the grant will support integrating Cybersecurity and New Technologies into existing FSU-PC curriculum, train teachers across the eight county region to teach Cybersecurity and New Technologies and provide support to upskill the region's workforce, separating military, and the spouses of military members serving in the Triumph region.

Initial classes began in Summer 2022 with a Teaching Technology Together (T3) Academy for teachers which will be one of a number of courses expanding to teachers in multiple counties in 2023. Additional courses are scheduled to start in 2023. 21 of 3,280 cybersecurity and new technologies industry certifications and credentials have been earned to date.

251 Santa Rosa County, Milton Interchange Park

Triumph Grant Award - \$15,378,683 Grantee Match -\$21,000,000 Total Project Cost- \$36,378,683

Granted February 2022, the Santa Miton Interchange Park project is currently on budget and on schedule for infrastructure construction completion at the end of 2025. The project will create at least 545 high wage jobs in the logistics and distribution and manufacturing target sectors.

257 Pensacola State College, Cybersecurity and IT Expansion

Triumph Grant Award – \$11,998,919 Grantee Match –\$30,975,000 Total Project Cost- \$42,973,919

Granted in March of 2022, the grant expands the Cybersecurity and IT program including the addition of higher level, in demand industry certifications. Construction of a new facility to house the program expansion is underway. The project is currently on schedule.

258 Bay County, Project Lightning Strike/Central Moloney

Triumph Grant Award - \$7,000,000 Grantee Match -\$14,970,291 Total Project Cost- \$21,970,291

Granted February 2022, Project Lightning Strike funds will initially be used by Bay County for site and infrastructure improvements followed by property tax reductions for the creation of at least 200 high wage manufacturing jobs by Central Moloney. The project is currently on budget and on schedule for construction to begin in 2023.

259 PEDC, Project Pioneer/Pegasus Laboratories

Triumph Grant Award - \$2,500,000 Grantee Match -\$15,165,000 Total Project Cost- \$17,665,000

In February 2022, Triumph granted the Pensacola Escambia Development Council (PEDC) funds toward the purchase of a building. The property is being renovated and leased by Pegasus Laboratories for the creation of at least 63 high wage life-science R&D and manufacturing jobs. The agreement was amended in March 2022 due to renovation timeline delays. The project is on schedule based on the updated timeline and the company has begun to fill the newly created position.

264 Wakulla County Schools, War Eagle Career Academy

Triumph Grant Award – \$20,011,606 Grantee Match –\$18,905,224 Total Project Cost- \$38,916,830

In May 2022, Triumph granted Wakulla County Schools funds to construct a career academy on Wakulla High School property. The career academy will expand career and technical education in Wakulla County in partnership with Lively Technical College (LTC) to meet regional workforce demands. The programs within the academy will prepare students for high-skill, high-wage, in demand jobs resulting in at least 7,450 industry certifications of which 320 have been earned to date.

The Academy classes will be open to students in grades K-12 during the school day, summer programs and adult students in the evening.

265 Florida State University Panama City, Collegiate Laboratory High School

Triumph Grant Award - \$7,651,600 Grantee Match -\$10,611,964 Total Project Cost- \$18,263,564

A grant was executed in June of 2022 for a new FSU-PC Collegiate Laboratory High School. The school will immerse students in a collegiate culture with supported services and defined curriculum pathways enabling students to earn dual enrollment credits toward a degree. It will engage students in advanced coursework in the fields of engineering, computer science, cybersecurity, and health sciences, among others.

The project will result in completion of 2,048 milestones being a Triumph-recognized CAPE certification, or a 15-credit hour bundle of lower division college core courses. The school is on schedule to open Fall 2023 and will reserve 50% of its seats for children of active-duty service members in the Triumph eight county region.

273 Bay County, Project Cast/Mocama Marine

Triumph Grant Award - \$3,675,000 Grantee Match -\$6,825,000 Total Project Cost- \$10,500,000

Executed at the end of September 2022, Project Cast funds will be used by Bay County to purchase a building. The building will be leased by Mocama Marine for the creation of 105 high wage manufacturing jobs by Central Moloney.

Please accept the following Annual Report for progress during fiscal year 2022, ending September 30, 2022 (project status provided by Jon C. Kanak, P.E., Water and Sewer Engineering Manager, and Nathan Sparks, Executive Director of One Okaloosa Economic Development Council):

Reporting Period - October 1, 2021 through September 30, 2022

The Hwy 90 East Water and Sewer Mains Extension project to the Shoal River Megasite was completed in the third quarter of 2021 (April – June 2021). The Engineering Certificate of Completion was submitted by Poly, Inc. stating the project was successfully completed in accordance with the plans and specifications. The project was successfully completed under budget, which resulted in approximately \$409,000 of unspent grant funds. On May 31, 2022, Triumph Gulf Coast and the County entered into the First Amendment to the Grant Award Agreement and agreed to allocate the remaining grant funds to extend water and sewer mains approximately 2,500 feet down Jericho Road. This extension will provide water and sewer availability to the northern two County-owned parcels at the Shoal River Ranch.

Currently the County is amending the original Highway 90 East project contract between the County and Poly, Inc to include engineering services for the extended water and sewer mains along Jericho Road. This contract amendment is going to the Okaloosa County Board of County Commissioners on November 1, 2022 for approval. Once approved, the amendment will not be executed until the contract amendment has been reviewed and approved by Triumph Gulf Coast.

Economic Metrics

Nathan Sparks, Executive Director of One Okaloosa Economic Development Council, provided the following current perspective on the status of the Economic Metrics requirement of the Triumph Grant Agreement:

The Triumph Gulf Coast performance metrics for this project are 250 net new jobs within three years of the last grant disbursement, such jobs being compensated at greater than the Okaloosa County average wage; OR 150 net new jobs within three years of the last grant disbursement, such jobs being compensated at least 150% of the Okaloosa County average wage; OR 500 jobs within five years of last grant disbursement, such jobs being compensated at greater than the Okaloosa County average wage; OR within three years of the last grant disbursement, a company undertakes a capital investment of at least \$25 million on the property.

During the course of the reporting period, One Okaloosa EDC submitted 21 responses to requests for proposal that were focused on specific parcels within Shoal River Ranch. In addition, a total of six prospect site visits were held with companies seeking to employ between 30 and 4000 workers and invest between \$20,000,000 and \$1.86 billion. All six of the projects undertaking visits were manufacturing-related, which typically align best with Okaloosa's skillset and wage structure (warehousing / distribution facilities are generally challenging for Okaloosa, as our average per capita wage is now the highest in the Triumph region).

Of note, following several months of in-depth discussions with Chinese-owned companies operating in the clean tech sector, One Okaloosa EDC recently made the decision to disengage from further discussions with these entities. In particular, this decision was based on escalating geopolitical sensitivities, potential national security threats associated with locating Chinese enterprises on Shoal River Ranch – a site that abuts Eglin Air Force Base – and the likelihood that state incentives for Chinese-based projects would be problematic at best. That said, One Okaloosa EDC is optimistic that a Letter of Intent for a 50-acre site will be finalized soon with a US-based enterprise that currently projects the creation of 350 manufacturing jobs. We fully recognize that this project alone would satisfy our Triumph performance metrics.

Recognizing the ultra-competitive nature of economic development and acknowledging the importance of advancing the property's overall readiness, the Okaloosa County Board of County Commissioners applied for and was subsequently awarded a Florida Jobs Growth Grant Fund award in the amount of \$3,217,188 by Governor Ron DeSantis in May 2022 to support critical site infrastructure at Shoal River Ranch. These funds represent 65% of an overall \$4,976,150 construction program including Highway 90 intersection improvements, Highway 90 signalization, railroad crossing upgrades / signalization, site entrance improvements (including monument signage and landscaping), 2400' of Jericho Road construction / paving (providing access to Okaloosa County's 500 acre interior site), construction / paving of the unnamed access road located adjacent to Okaloosa County's northern 88 acre site, water/sewer extensions and 2700' of fiber conduit runs. Design / engineering for these improvements is now underway. Following permitting and public bid solicitation, construction is slated to get underway in July 2023 with completion expected in July 2024.

Looking to the future, it is especially noteworthy that the Okaloosa County Board of County Commissioners has initiated efforts to construct a new wastewater treatment plant on the southern end of Shoal River Ranch. At present, only 400,000 GPD of available wastewater capacity exist at the Bob Sikes WWTP located seven miles northwest of the property. These limitations have hindered the County's ability to pursue projects at Shoal River Ranch requiring a significant amount of wastewater. The new plant is projected to have a minimum of 4,000,000 GPD of capacity and slated to be on-line by Dec 2026. Lastly, it should be noted that Okaloosa County currently has an additional 260 acres under contract for purchase on the southern end of Shoal River Ranch adjacent to I-10. In addition to providing additional lands for economic development purposes, a portion of the parcel may be needed for effluent disposal associated with the planned wastewater treatment plant.

Please accept the following Annual Report for progress during fiscal year 2022, ending September 30, 2022 (project status provided by Carisse M. LeJeune, Surtax Project Manager, and Nathan Sparks, Executive Director of One Okaloosa Economic Development Council):

As Okaloosa County, its partners, consultants, contractors and permitting agencies recover from the negative economic impacts of COVID 19, work on the Southwestern Crestview Bypass has continued on course and on schedule. The Triumph Grant Award has had an enormous impact on the progress of the entirety of the project, providing both the financial and motivational impetus for the county moving forward at a steady pace, and providing added incentive to overcome the myriad obstacles posed by a pandemic, transfer of railroad ownership and nearly insurmountable slowdowns in wetland permitting. Okaloosa County is extremely grateful for the partnership forged by Triumph Gulf Coast, Inc., and is proud to report the following progress.

Funding

As noted in the prior report, Okaloosa County undertook a Bond Refinancing Issuance, secured by half-cent sales tax, with infrastructure surtax revenues committed to cover the debt service payments for the new portion of the refinancing through 2029, in order to provide up to an additional \$25 million in funding for the overall project. That, combined with previously committed County and City Infrastructure Surtax funding, CIP funds (funded through local option gas tax revenues) and ongoing TIFF fund revenues ensured the County's ability to successfully meet its financial commitments.

In 2020, the Florida Department of Transportation included its funding commitment for the I-10 interchange portion of the project in its 5-year work plan. The plan was approved and appropriated by the Florida Legislature, and the budget signed by the Governor without change to the appropriation. The Department recently selected a design-build team to complete the design details and construction of the interchange, continuing to move the project forward while simultaneously cooperating and assisting the County with its efforts in wetland mitigation and permitting.

Design

Immediately following the Grant Award, the County accelerated its efforts in all phases of the design of the project, with special emphasis on finalizing the line and grade for completion of the right-of-way requirements. The final design for the entire project was completed in 2020, including full construction plans for Phase IV, Phase V and the East-West Connector.

Right-of-Way Acquisition

Negotiations for acquisition of required right-of-way parcels began in February 2020. All of the properties required for construction of the project were acquired through negotiation or by process of eminent domain by the end of the third quarter of 2020. Just two of the three parcels acquired through process of eminent domain are now awaiting the court's due process for determination of the final fair market value. A settlement agreement for one of the original three parcels was negotiated and approved by the Okaloosa County Board of County Commissioners on October 18, 2022. Those portions of the right-of-way to be maintained after construction by the County or City, respectively, have been identified and addressed in an Interlocal Agreement approved by both the County and the City.

Acquisition of rights to construct the bridge over the railroad proved challenging. When negotiations for the acquisition of appropriate rights to cross the railroad commenced (including acquisition of air rights, with specific elevations of the encroachment delineated across the span of the horizontal right-of-way limits) the then-recent CSX sale of the rail corridor to Florida Gulf & Atlantic Railway complicated communication and negotiation efforts considerably. During the course of those negotiations, the County discovered that CSX had actually retained the air rights in the conveyance to FG&A, resulting in the requirement to secure approvals of both the current and prior owners; the former for easement/right of entry for maintenance and the latter for the aforementioned three-dimensional area for aerial encroachment. Although challenging, the County successfully reached agreements with both railroad companies for construction and ongoing maintenance of the bridge over the railroad.

Permitting

The permitting process, as expected, proved to be one of the most difficult and time-consuming aspects of the development process. Initially, purchase of wetland mitigation credits was planned from the Gin Hole Mitigation Bank in the Yellow River and Shoal River watershed, which was on a permitting track parallel to the County's project efforts. The Covid 19 pandemic played an unexpected hand in effectively stopping progress on both the County's wetland permit reviews and the Mitigation Bank permitting. Both the US Army Corp of Engineers (USACE) and Florida Department of Environmental Protection (FDEP) ceased field/project visits by staff in response to the virus, effectively shutting down the wetland permitting processes. Ultimately, USACE transferred their permitting processes to FDEP. While that was viewed as a generally positive move for the project, the Gin Hole Mitigation Bank permitting process still remained at a standstill, leaving the County very limited, and possibly very expensive, options for moving forward.

The breakthrough for wetland permitting began to come to fruition in the form of agreement by the FDOT to allow the County to purchase some of its reserved credits for wetland mitigation from the Sand Hill Lakes Mitigation Bank in Washington County. That breakthrough was fully realized when the FDEP and Northwest Florida Water Management District (NWFWMD) acquiesced to the County's purchase of mitigation credits outside the project watershed, allowing the Sand Hill Lakes Mitigation Bank purchase of credits for the project to go through. As of this writing, the project is fully permitted.

Contracting

After design of Phase IV of the project was complete, it was determined that project timing and economies of scale might provide the best result by allowing the contractor for Phases I-III, C.W. Roberts Contracting, Inc., to add Phase IV to its existing contract. The County solicited a reasonable negotiated price for appending Phase IV to the existing contract for Phases I-III, and secured Triumph approval for the action. The contract with C.W Roberts Contracting, Inc. was appropriately amended, and Phase IV of the project is still under construction.

The County went out for separate bid for the Phase V and East-West Connector portions of the project and received three responsive bids from responsible bidders. After carefully consideration, the County selected the apparent low bidder, Anderson Columbia, published a notice of Intent to Award, and executed the contract on November 17, 2020. The contractor's patience through the completion of the wetland permitting process was finally rewarded; the Ground Breaking ceremony was held on September 13th, 2021, the contractor was issued a Notice to Proceed, and construction of Phase V of the project is still underway.

Economic Metrics

Nathan Sparks, Executive Director of One Okaloosa Economic Development Council, provided the following current perspective on the status of the Economic Metrics requirement of the Triumph Grant Agreement:

The Triumph Gulf Coast job creation performance metric in support of the South Crestview Bypass project is the creation of 1300 net new jobs within EMSI Sector 901200 during the 10-year timeframe between 2019 and 2029. The 1300 jobs must be over and above the 243 jobs that EMSI projects will be created "naturally" during the defined 10-year timeframe. Per Okaloosa County's Triumph Grant Award Terms Sheet, the starting point / baseline for EMSI Sector 901200 was 16,052 existing workers in Q3 2019. Taking this figure, along with the projected growth of 243 jobs within this sector by 2029, the forecasted workers for EMSI Sector 901200 by 2029 is 16,347. The agreed upon 1,300 increase in sector 901200 over baseline means that by 2029, Okaloosa County's employment level in EMSI sector 901200 needs to equal 17,595, (i.e., baseline projected growth of 243 from the 2019 base of 16,052, plus incentivized growth of 1,300).

The Panama City Port Authority is pleased to provide the Triumph Board of Directors the fiscal year 2022 update for the East Terminal. The grant agreement between the Panama City Port Authority and Triumph Gulf Coast requires the Port Authority to achieve one of three performance metrics. This annual report provides an update for each of these goals.

New Jobs

The Port Authority has agreed to generate 148 new jobs directly related traditional port activity and 250 additional portmanufacturing related the iobs. Due to setbacks of Hurricane and Michael COVID-19 pandemic, Triumph has granted the 18-month Port extension to March 30. 2025 in meeting this metric.



Based on a 2021 Martin Associates Economic Impact Study for the Port Authority there are 3,075 direct, indirect, and induced jobs supported by cargo activity generated at the Port. Additionally, 7,714 related jobs are supported by Panama City cargo. As port activity continues to increase, the Port will continue its efforts to grow tonnage levels at the East Terminal to produce the 148 jobs by March 2025.

New Cargo Activity

The Panama City Port Authority is committed to adding 500,000 tons of new cargo activity at the East and West Terminals by March 2025. The Port just completed a record year for cargo activity, with cargo tons increasing four percent year-over-year to a total of 2,030,424 tons handled at the East and West Terminals. The Port handled more than 450,000 tons of break-bulk forest products and lumber in 2022, with 235,000 tons of that cargo moving through the East Terminal. Container activity has also increased, with the Port handling 54,862 TEU's during 2022, representing a ten percent increase in the number of TEU's moving through the Port.

The Port handled a total of 235,210 tons of cargo through the East Terminal in 2022, which includes 199.567 tons of kraft linerboard and pulp, along with 35,643 tons of import lumber. Twenty-eight ships called the East Terminal in 2022 to load and unload the above cargo tonnage. The Port Authority has seventy-five full-time employees, compared to sixty-six in the prior year.



Additional Port Revenues

The Port Authority recorded revenues of \$19,049,341.00 for fiscal year 2022, which is a port record. This represents a nine percent increase over fiscal year 2021. Driving the increase were strong forest products and biomass wood pellet exports, and growth in containerized cargo volumes to and from Mexico. The Port has surpassed its goal to record annual revenues of \$18,000,000.00 by November 2025. The Port's audited financial statements for the current fiscal year will be available in the first quarter of 2023.

The Year Ahead

The Port continues to attract new commercial opportunities through the East Terminal. Cargo loading to Colombia and Ecuador is expected to increase in 2023. The Port will also handle additional Far East exports next year, continuing to build export tonnage on this trade lane that commenced in 2020. Two steamship lines, Ultrabulk and Norlat Shipping, will continue calling in 2023 with import lumber from North Europe.

As cargo activity continues to increase, the Port Authority is focusing its efforts on strategic planning for future expansion. The Port will commence the update of its Strategic Master Plan in November, with a focus on expanding cargo and berth capacity at the East Terminal. The Port Authority looks forward to strong tonnage and financial results for 2023, and continued progress towards meeting each of our performance goals.

In accordance with s. 288.8016, F.S. Santa Rosa County is pleased to provide an annual report on Project #72 Whiting Aviation Park. A grant agreement was executed on January 17, 2019, providing \$8,523,655 in Triumph funding for infrastructure improvements to 40 acres at Whiting Aviation Park. The completion deadline (grant end date) was December 31, 2021.

We are happy to report that design was completed in February 2020 and construction was completed in December 2021. Metrics for the project included meeting one of the following criteria within three years of project completion: (a) creation of 200 net new jobs greater than 150% of the average county wage; (b) creation of 300 net new jobs at greater than 115% of the average county wage; or (c) \$25,000,000 in capital investment. Santa Rosa EDO will satisfy the metric requirements by Leonardo Helicopters opening a helicopter support center at the Aviation Park.

MICHAEL A. ADKINSON, JR., SHERIFF Office of the Sheriff, Walton County

The partnership between the Walton County Sheriff's Office and Emerald Coast Technical College has produced 321 certificates to date as a result of the Triumph grant for our agency. Since 2014 when Sheriff Michael Adkinson was assigned authority of the jail, the vision has been constant with a commitment to protect the public, maintain order and build better people. The funds provided in the Triumph grant have been and continue to be essential in order to successfully fulfill our mission.

Although providing programs in 2020 and 2021 proved difficult due to COVID-19, the agency has been very successful in resuming services and obtaining certificates for the 2022 year.

Since the funding of the Triumph grant, the following programs have been implemented within the jail: ServSafe, Anger Management course, Residential Substance Abuse Treatment Program (R-SAT), Parenting course, OSHA 10 certification, Introduction to Culinary program, Adaptable Equipment Proficiency (ADEPT) certified Heavy Equipment program and Commercial Driver's License (CDL) program.

The agency is in the process of having the Heavy Equipment Operator class added to the Triumph grant as additional approved certificates. A partnership with Heavy Equipment Colleges of America has allowed inmates at the Walton County Jail the ability to train and test to receive their Adaptable Equipment Proficiency Testing (A.D.E.P. T.) certification. There is currently two certified Train the Trainer Vocational Instructors for this program, allowing one to instruct inmates and the other to test upon completion of the class. A third instructor was hired in July of 2022 and will attend training on December 5th and 6th to obtain his Train the Trainer certification.

The Sheriff's Office has recently launched the Commercial Driver's License (CDL) course and hopes to have two inmates receive their CDL by the first of the year. The ability to offer the CDL program is solely based on funds provided by the Triumph grant. Without the grant, we would not have the resources for this type of program.

We are always excited to see inmates excel in our programs; however, their success upon being released is what brings us the most satisfaction. When an inmate is able to maintain a job, support a family, avoid criminal behavior and be a productive member of society, we know we have truly been successful.

Although we have had several success stories, the most recent one that comes to mind is Mr. Christopher Carroll. Mr. Carroll has been coming to our facility on and off since 2021. Mr. Carroll requested to participate in our Heavy Equipment program. He completed the program and was released prior to our graduation ceremony; however, Mr. Carroll returned on graduation day to attend with his fellow classmates and Vocational Instructors, Mark Simmons and Tim Castiglione. "They gave me the confidence to present myself and ask for a job," said Carroll. "Feeling good about myself is something I've never experienced." Since one day after his release, he has been working for Moss, a nationwide, family-owned construction company running a skid-steer on a project in Walton County.

"It gives them a chance to learn something new," said Sheriff Michael Adkinson. "The rest is up to them."

The primary objective of the programs we offer is to give the inmates the ability to obtain technical skills and knowledge that will benefit them as they reintegrate into society. We are very thankful for the opportunity the Triumph grant has provided to be able to pour into the lives of inmates at the Walton County Jail. In accordance with s. 288.8016, F.S. The City of Pensacola is pleased to provide an annual report for Project #120, Project Titan. In April 2019, Triumph Gulf Coast and the City of Pensacola executed a grant award in the amount of \$66 million for the construction of three MRO hangars and related infrastructure with a completion deadline of April 2025 (subsequently amended to October 29, 2025).

FUNDING STATUS

The total cost for design and construction of Project Titan is \$210,125,000. The financial commitment from Triumph is \$66,000,000 leaving a balance of \$144,125,000. The balance of funds has been committed as follows:

Governor's Job Growth Fund	\$18,875,000
City of Pensacola	\$15,000,000
Escambia County	\$15,000,000

To date, no Triumph funds have been expended, as the full Triumph award will be applied to the combined Hangars 3 and 4.

KEY MILESTONES

The first element of Project Titan, design and construction of Hangar 2, is near completion, with beneficial occupancy in November 2022. The total cost for Hangar 2 is approximately \$66 million, funded with a combination of the above referenced match funding sources.

Construction for the second element of Project Titan, combined Hangars 3 and 4, is anticipated to begin in early 2023. The Basis of Design (BOD) is complete and the City is currently conducting the procurement process for a design-build firm, with final selection anticipated in December 2022.

The project remains on schedule and on budget, with an anticipated project completion date in first quarter 2025.

Franklin County Schools continues to make strides forward with its CTE programs. The funds provided from the Triumph grant are invaluable in moving our programs to the next level and being able to offer our students current and relevant training.

Over this past year, FCS has met its obligation for certifications for this project for Welding and Digital Tools/Nursing. Digital Tools/Nursing required certificates amount was 750. Students have earned 766 digital tools certifications. This milestone was met previously.

Welding students earned 21 certifications this past year, bringing the total certifications earned under this project to 36. The required total was 27 certifications. FCS has met this obligation. In addition to meeting the certification requirements, welding students are dually enrolled in college classes with Lively Technical College for the 22-23 school year.

5. Blended Crafts:

- a. Both the Welding and Carpentry programs at WHS share the same Core Curriculum, equipment, and dual-certified instructor. This allows students to learn skills and tools used in both trades and those students who desire to do so can obtain certification in both areas. WHS had two students certify in both Welding and Carpentry simultaneously.
- b. Seventh & Eighth grade students participate in wheel classes designed to provide students an opportunity to explore different electives. Students experience a different elective each grading period, but are permitted to repeat those for which they express a particular interest or aptitude. This program has allowed middle-school age students an opportunity to learn basic welding techniques.

6. Community Visibility:

a. In a collaborative program with Eastern Shipbuilding Group and the Bay County Artificial Reef Association (BCRA), Wewahitchka High School is constructing artificial reefs with will be deployed in local waters. Eastern Shipbuilding Group supplies the materials used. The reefs are constructed by WHS students to the specifications of BCRA. Please see the attached flyer.

- b. The Welding and Carpentry programs sponsor a booth at the annual Tupelo Festival each May to showcase and sell their crafts with all proceeds being returned to the respective programs. The 2021 festival was very successful and in addition to the sales made at the festival, customers continue to reach out to place orders.
- c. Instructor has established contacts within area companies that employee welders to facilitate possible employment upon certification/graduation. Students are made aware of employment opportunities and career options as part of the curriculum and participate in fieldtrips to nearby vocational centers to encourage advancement in the area beyond high school. Fieldtrips to Eastern Marine and Haney Vocational Centers were made the second semester of SY21-22. Lively Vocational College will be visited later this school year.

The City and Eastern are communicating daily to ensure all projects are monitored and all grant requirements are accurately managed.

This report is submitted for the annual period October 1, 2021 through September 30, 2022 and the quarterly period from July 1, 2022 through September 30, 2022.

As required by section 5.4 of the grant award agreement, the most recent audited financial statements of both the City of Panama City and Eastern Shipbuilding Group have been submitted via smartsheet.

As of September 30, 2022, the City had filed seven funding requests totaling \$10,446,255.00 for construction related costs incurred in relation to Project #185 and all seven had been approved and fully funded by Triumph at September 30, 2022. As of September 30, 2022, additional costs had been incurred related to the project totaling \$3,087,519.23 of which \$2,510,153.14 is being requested from the Triumph award in Funding request #8 which was submitted in October 2022. As of September 30, 2022, Eastern Shipbuilding Group has been invoiced for and has remitted to the City its full required match in the amount of \$2,414,556.08 for costs included in funding requests #1 through 7. Eastern will also be invoiced for \$577,366.09 of its required match for additional construction costs incurred that will be included in funding request #8 to be submitted in October 2022.

Updates for projects in process are as follows:

Aluminum Fabrication Building

The building is complete and we are working through some warranty items. The last remaining item is the drainage system. The bid package should be complete within the next week or two so we can start the bid process.

Phase I Uphill Bulkhead

HG Harders and Sons has completed installation of all sheet piles and walers. They are installing the top cap and handrails. The remaining handrails and last set of steps are at the galvanizer and should be delivered by October 14, 2022. The demolition of the Whitaker Pier and dolphins are complete and closed out.

FIN Dredge Project

Diamond Services has completed the Fin Dredge Project. All material has been removed from Allanton. We are working on final survey and close out invoicing.

Bollard Project

Eastern Shipbuilding has completed the installation of the pad eyes and the bollards along with the Change Order for the demo of head office to include cutting the hill down to grade.

Status of USCG Offshore Patrol Cutter Project

ESG continues to make excellent progress on the OPC project. ESG is currently in the process of constructing OPC's #1, #2, #3 and #4. Construction is currently on schedule and delivery of OPC #1 is expected in 2023.

ESG submitted its FPR (Final Proposal Revision) to the USCG for Stage 2 of the OPC Program and the USCG awarded that portion to Austal USA. ESG protested the decision with GAO. ESG eventually withdrew its protest with GAO due to the USCG's unwillingness to disclose critical information to ESG's attorneys under protective order. ESG recently filed suit in the Court of Federal Claims, where it is continuing to pursue the protest of the award to Austal USA.

In the meantime, ESG continues to execute for its customer on the OPC project for Hulls 1-4. This project, along with ESG's commercial business, continues to grow and our workforce is growing to support it.

<u>Progress towards achieving performance metrics</u>

ESG continues to recruit employees to the community to support its commercial and government business.

Mr. Rick Harper conducted an informal audit of the systems ESG is utilizing to track the performance metrics required to be met under the Triumph agreement, as well as the current progress towards achieving the performance metrics. Positive progress was made at the meeting and the Triumph team gained additional comfort that ESG's approach to tracking performance metrics was sound. Triumph Gulf Coast followed up with a letter giving a similar statement.



Triumph Annual Report

Walton Works Training Center of Excellence – Project #187 Annual Report: November 1, 2021 – October 31, 2022

Northwest Florida State College has successfully implemented the Walton Works Training Center of Excellence project and is generating certifications that support industry demand for the region.

Annual Construction Update

All construction activities have been completed.

Annual Personnel Update

James Bailey continues to oversee the building construction specialist program with both academic and apprentice students attending his courses. Mr. Bailey completed the OSHA instructor's course in January and was approved to advertise, set course days and times, and register nationally for DOL 10 and DOL 30 construction safety courses. Thus, the Walton Works facility became an authorized OSHA training facility. Since this time, the College has issued 56 OSHA certifications as of October 2022.

Lindsay Nix replaced Jason Cotton in January 2022 as the Public Safety Training Coordinator. Under Ms. Nix's leadership, successful Law Enforcement, Emergency Medical Technician, Paramedic, and Fire Fighter training cohorts have been run at the Training Center of Excellence.

Carlos Smith was recently hired as Instructor of Welding Technology following Matthew Stewart's resignation. Mr. Smith teaches the welding technology program courses at the facility.

Guillermo Ortiz-Caceres completed the setup of the cybersecurity lab and has scheduled course offerings for workforce and high school students seeking certifications in this field. Mr. Ortiz-Caceres is prioritizing recruitment, enrollment, and retention in courses that lead toward stackable credentials, to include the A.S. degree.

The HVAC apprenticeship program started as part of the Walton Works project with students beginning coursework in August 2021 overseen by Danny Meineke. The HVAC program has shown strong growth with 12 registered apprentices training in the program, working for 6 area employers.

Annual Program Development Progress

Students have been earning industry certifications through our Construction Trades, Welding, and Public Safety programs. October 1, 2022, and has exceeded this goal by reaching 945certifications.

Faculty from the Cybersecurity and Information Technology department met with Walton High School students on October 13 to showcase program offerings and assist with enrollment questions. The Cybersecurity and Information Technology programs are offering two classes in the Spring that lead to industry certification.

- Networking Foundation leads to the CompTIA Network+ certification
- PC Hardware A+ is the first step toward the CompTIA A+ certification

This letter is to serve as the 2022 Annual report for the Walton County US 331 Water and Sewer project Triumph Project #190. A "Limited" Notice to Proceed was issued to the Contractor, L&K Contracting, on August 11, 2021. Construction commenced on in December of 2021. At the time of this report, approximately 90% of the water main and force main has been installed by the Contractor. The remaining work items are the north and south lift stations for the project and final seeding and restoration. On March 11, 2022, the Contractor informed the County in writing that the precast materials for the pump stations were on back order until May 6th, 2022. The material supply shortage is an ongoing issue in the construction industry. Based on the good-faith documentation provided by the Contractor, the County allowed the contract time to pause until the delivery of the materials on or about May 6th, 2022. There were further delays in the pre-cast materials, electrical pump station equipment and air release valves. Construction didn't resume until July 5th, 2022.

The revised, estimated Contract Summary as of the date of this letter is to be substantially complete by September 27th, 2022. The final acceptance is by Thursday, October 27th, 2022. It is anticipated that the Contractor will be substantially complete by October 27th, 2022, but will not be ready for final acceptance on this date. The remaining work items to be completed are the final restoration of asphalt driveways, power to the north and south lift stations, fencing around the lift stations, and any final sodding in FDOT Right of Way.

The Triumph grant has two performance metric requirements 1) creation of at least 100 Florida Qualified Targeted Industry jobs and 2) the creation of the 100 jobs must be accomplished within four years of the commencement date of December 31, 2020. To date, the County and the Economic Development Alliance have sold a 10 acre parcel of land to a manufactured home business that is in operation and a 5-acre parcel to an unmanned aerial vehicle manufacturer to Eglin Air Force base. The jobs created as a part of these developments will count towards the New Job definitions and as part of the Florida Qualified Target Industries.

Triumph Project #200 Annual Summary

Franklin County Schools continues to make strides forward with its CTE programs. The funds provided from the Triumph grant are invaluable in moving our programs to the next level and being able to offer our students current and relevant training.

With the Triumph board approval, FCS began working toward new certification totals in Drones, Medical and Digital Tools programs, and adding certifications in Building Trades and Construction Design Technology. The new totals approved by the board are: Drones: 144; Medical: 156; Digital Tools: 146 and Building Trades: 42.

Students successfully earned 2 drone certifications and 143 digital tools certifications. No certifications were attained in the Medical and Building Trades programs.

Building Trades students spent the majority of the previous school year overcoming curriculum access issues before completing the required NCCER CORE curriculum, the certification required to attain any of the higher NCCER certifications. With curriculum access issues resolved, there are a minimum of 2 students and possibly up to 12 students projected to earn higher level NCCER certifications this school year.

The Medical program suffered this past school year due to the program instructor being on extended medical leave. The instructor chose to retire late in the summer rather than return to the classroom, leaving the school district without an instructor to begin the current school year. FCS is currently advertising for a Medical instructor and is also reviewing alternative delivery methods for the medical curriculum to put this program back on track. FCS intends to resume the program in January, 2023.

Through focused recruiting the drone classes have 9 second year students and 33 first year students. These students will sit for the sUAS Level 1 Safety Certification prior to the 2022 holiday break. Students who successfully complete the safety certification will move immediately to the Visual Line of Site (VSO) curriculum and begin working toward that credential. Plans for the drone program include adding two more certification opportunities over the next school year in video editing and 3D printing. FCS held its first Drone Rodeo in March, 2022. This was a competition between area drone programs held on the FCS campus. This activity made a significant difference in the number of first year students in this program.

Current Industry partner Huntington Ingalls Industries is working with PCMI to add Underwater Unmanned Vehicles (UUV) operator certification training in a possible partnership with Naval Surface Warfare Center, Panama City.





PCMI Properties Inc.

PCMI is partnering with FAMU to create a CEU course consisting of three parts for 100 contact hours in Underwater Robotics. This course is slated to go live Fall of 2023. This will be a first step towards a possible dual enrollment college credit course at FAMU in Underwater Robotics that will take place at the Maritime Academy in Panama City.

Chevron and the AMIkids Foundation have partnered to donate \$20,000 towards an Underwater Robotics STEM classroom at PCMI which is currently under construction.

Aviation

The Maritime Academy has added the Gaetz Aerospace Institute course to its offerings. The first introductory course takes place Spring of 2023 with an anticipated enrollment of 20 students. Fall of 2023 will start the dual enrollment portion that also contains the industry certification courses. We anticipate the first aviation related industry certifications Fall of 2023.

Two Gleim FAA approved simulators were purchased and installed at the Maritime Academy to assist students with flight training. The local Civil Air Patrol (CAP) unit has moved its meeting location to PCMI and is also accessing the flight simulators.

Construction

The Maritime Academy has adopted the NCCER CORE and Carpentry Curricula and classes start in Spring of 2023 with an anticipated enrollment of 20 students. The students will earn NCCER certificates in CORE, OSHA 10, and Carpentry. PCMI is in the process of adopting Forklift Driver and HVAC certification courses as well to be conducted in the Spring semester of 2024.

PCMI has completed an agreement with the Bay County Sheriff's Office, the local Career Source Center and the

Federal Department of Labor to provide NCCER CORE, OSHA 10, and Carpentry certification courses in the County Jail and at the Career Source Center for young adults ages 16-24. Courses start Nov 2022. The first industry certifications are expected in Dec 2022.

Plans are currently underway to expand the course offerings at the jail to include HVAC certification pending approval of the Federal Department of Labor.

Accomplishments of the Project:

- The D-105 simulation center continued to be utilized for the practical nursing and LPN to ADN programs throughout the 2nd quarter. Simulations have now been performed in every Practical Nursing and LPN to ADN course offered at the Gulf Franklin Campus.
- In the 3rd quarter, 2022, 7 Practical Nursing students and 12 LPN to ADN Weekend students obtained licensure as LPNs and RNs, respectively.
- 3. As of 10/27/22, there are a total of 42 students in the practical nursing program of which 22 will graduate in December, 2022. There are currently 45 students in the Weekend LPN to ADN program of which 26 will graduate in December, 2022. Currently there are 20 students in the LPN to ADN Transitions course that will advanced to the weekend LPN to ADN program in January, 2023.
- 4. The simulation center has now been updated to fully implement sim patient barcode recognition and medication barcode recognition to enable electronic health care record and medication administration documentation at bedside.
- The majority of the simulation and lab equipment has been received and is being used in the modular classrooms until completion of the A Building remodel.
- 6. The modular classrooms continued to be utilized through the 3rd quarter.



Challenge(s) Project Has Encountered/Resolutions:

- 1. Challenge: Supply Chain Delay related to Covid-19: The supply chain delay caused additional delays in starting the A-Building remodeling project.
- 1. Resolution: The (5) portable classrooms are currently in use as 3 Practical Nursing and LPN to ADN Weekend classrooms and a skills lab. Students are able to receive their nursing lectures and practice skills in an environment conducive to learning. When the A-Building remodel is completed, the classrooms and labs will relocate to their permanent location.
- 2. Challenge: Covid-19 pandemic: There has been limited access to nursing homes and hospitals for CNA and PN clinical hours. Delay of the remodel of A-Building has impeded restarting the CNA program due to the strong focus on bedside skills needed for quality training. The current situation inhibits the start of another program at this time.
- 2. Resolution: The PN program adjusted clinical hours to the hospital and rehabilitation settings and used simulation instead of the nursing homes and limited hospital access to acquire the necessary hours. The CNA program will be offered more frequently and/or allow more students per class to compensate for the delay in starting the program. The CNA anticipated restart will occur in the the Spring, 2023 semester after completion of the A-Building remodel.
- 3. Challenge: Decrease in applicant pool related to Covid-19 pandemic and current economic factors, such as gas and cost of living expenses.
- 3. Resolution: Continued marketing and advertising to attract new applicants;



Plan for continued growth of the programs by partnering with Trio and other organizations to promote GFC nursing programs enrollment. Plan to offer a nursing career workshops and/or basic competency boot camps to promote additional interest in the community and better prepare potential students for enrollment into the nursing programs.

Assistance Required to Ensure Success of Project:

- 1. Ongoing support by GCSC administration.
- 2. Vigorous marketing campaign to promote all GFC nursing programs.

The Triumph Nursing Expansion project produced 19 certifications in the 3rd quarter, 2022.

This addition will bring the project total to 129 certifications through September 30, 2022.



I. Modular Buildings:

1. Landscaping is in progress. A twenty-five feet area will be landscaped on three sides of the building and irrigation has been added.

II. Building A Remodel:

- 1. Low bid (BNL Contractor Services LLL) was submitted to GCSC Board on Thursday, April 22, 2022 for approval.
- 2. Contractor will have 120 days to complete remodel from June 15 (Notice to proceed date).
- 3. Contractor has begun work as of early July 2022 and should be completed by Mid-October, 2022.
- 4. Demo of lights and ceiling is completed. New lights and ceiling have been installed.
- 5. Walls have been installed and painted.
- 6. Doors are installed and glass should be installed by October 21.
- 7. Electrical is being installed currently.
- 8. Cat-6 cabling is being installed. Cables are run and are currently being terminated and tested.
- 9. Remodel should be substantially completed by October 21 with the exception of some AV Ceiling Mounts for the AV panels in the classrooms. Mounts are on order, but have been delayed by supply issues. (Mounts are currently scheduled to ship October 26). AV Mounts will be treated as a punch list item.
- 10. HVAC will require a "Test and Balance". However, we have an issue with some controls that have been ordered but not delivered due to supply issues. Once controls are received, the T&B will be performed as a punch list item.
- 11. The VALT system (cameras and recordings) is scheduled to be installed November 14-18.



- 12. The beds and lab equipment will be moved from the modular buildings back to Building A mid-November after the lab portion of classes is complete.
- 13. Once remodel is complete, Nursing students will occupy remodeled Building A and UMV will occupy most of modular buildings. The nursing program is scheduled to begin using the remodeled Building A for the Winter term beginning in January, 2023.



It is with great pleasure that Florida's Great Northwest (FGNW) submits this annual report on the progress we have made in 2022 with our grant that was awarded to us on March 3, 2020.

Please see the outline below of the progress made this year.

- As stated under Section 4.2 (4) of the Grant: FGNW executed a second contract with ABLE Operations to perform the update of the previously completed labor supply and demand analysis study as outlined in the grant agreement. ABLE Operations has completed the quantitative portion of the study and is finalizing the qualitative portion of the study for some of the newer education programs such as cyber security and drone technology. Dr. Aaron Schmerbeck with ABLE Operations, FGNW and Triumph staff will be reviewed the updated findings in mid-November.
- As stated under Section 4.2 (5) of the Grant: Building off the successful and award-winning "Beyond Our Beaches" campaign from Phase 1 of the Marketing Grant, FGNW developed a strategy to continue awareness of the Northwest Florida brand through additional promotional assets and targeted strategies focused on reaching company executives and site selection consultants. A detailed plan proposal can be found in the supplemental section.
- As stated under Section 4.2 (6) of the Grant: Since the grant's original execution date, an amendment agreement was made to allow FGNW to fund a position through the Florida Education Foundation to extract data from the Florida Department of Education's (FDOE) education data warehouse (EDW). FGNW staff continues to work with the Florida Department of Education and the Florida Education Foundation to allow for extraction of industry certification data. A contract between the Florida Education Foundation, FGNW and ABLE Operations is in draft to come to an agreement to perform this work.



FGNW is focused on promoting the assets found in Northwest Florida to site location selectors and company decision makers, including the unique opportunities with the Triumph Gulf Coast fund. The results FGNW has had in generating job creation leads and interest for this region is evident and can be showcased in the organization's annual report, which is included in this update. Wakulla County School Board has partnered with Lively Technical College, under the Triumph Gulf Coast Fund, to provide educational opportunities through the Lively Aviation Training Facility in Tallahassee in Aviation Maintenance General Technician, Aviation Airframe Mechanics and Aviation Powerplant Mechanics. Project #215 was executed in September of 2020 and began in the fall semester of 2020. So far, Lively students have earned 70 FAA industry certifications reported to the Triumph Gulf Coast Board. The initial allocation was used to pay instructor salaries and certification fees for students. With the additional funds received from the earned industry certifications, Lively intends to purchase an airplane and additional aviation equipment, in addition to paying the previously mentioned expenses.

Northwest Florida State College is moving forward with multiple new programs at the Aviation Center of Excellence in Crestview. Please find enclosed a summary of our activities thus far.

Annual Construction Progress

All construction and renovation activities have been completed.

Annual Personnel Update

Over the past year, four positions have been filled:

- 1. Recruitment and Placement Coordinator
- 2. Office Specialist
- 3. Powerplant Faculty
- 4. Lab Coordinator

Annual Progress, Challenges, and Highlights

Equipment

The College uses a combination of training aides, simulators, and aircraft to support a progressive training model in all its programs. All equipment, training aides, and materials required to support the Airframe and Powerplant programs are in place. Also, the College is proud to provide an FAA-certified Advanced Aviation Training Device (AATD), which is a full-motion flight simulator. This simulator is utilized by students in the Professional Pilot Technology program. Students can sharpen their skill as an aviator without cost while progressing through their flight training.

Curriculum and Program Development

The College worked with the FAA to develop curriculum, policy manuals, and procedures to meet the FAA CFR Part 147 Aviation Maintenance Training (AMT) school requirements for the Aviation Powerplant Mechanic program. Per FAA requirements, all equipment, training aids, and planes were purchased and delivered prior to scheduling a site inspection. On October 17, the College passed an FAA-conducted site inspection. The FAA approved the Air Frame and Powerplant certificate rating on October 27.

The College was happy to partner with Emerald Coast Aviation at Bob Sikes Airport to begin flight training for students in the Professional Pilot Technology program this fall. This Associate of Science degree program allows students to earn multiple ratings which prepares them for a fulfilling career as a professional pilot. Eight students began their flight training and are progressing well.

The College also launched a new dual enrollment program this Fall for high school juniors and seniors. There were four students enrolled in the initial cohort of this program. This program is

intended to progress students through the four General AMT classes associated with the Aviation Airframe Mechanic's program. Class is scheduled from 7:00 to 8:45 in the morning, allowing students to stay enrolled at their high school. One class is taken per semester, so students who begin the dual enrollment program in the fall semester of their Junior year can complete all four classes by the time they graduate high school. Students who complete the program are awarded a General AMT Certificate from the College, a credential which affords them the opportunity to complete the FAA AMT General Examination, which is CAPE funded.

Recruitment and Outreach

A challenge for last year was that recruitment could not occur while equipment was being ordered/received and the program was still in development. This year, hiring the Recruitment and Placement Coordinator has been instrumental in boosting the Center's enrollment, which is 47 students as of October 2022. She visits the three area high schools in Okaloosa County regularly to recruit students. She has also hosted recruiting events at the Center and coordinates with main campus recruiting events to ensure the Center's programs are represented. Strategic Communications has also boosted the Center's social media presence by posting about the Center regularly.

Lockheed Martin sponsored the annual Propel Workshop Series with a gift of \$2,000, which took place on October 15 and provided hands-on experiences for secondary students in Aviation and Aviation Maintenance. This year, the event invited local middle school students to participate in four stations: 1) flight simulator 2) aircraft engine runs 3) aircraft systems familiarization and 4) drone flying. Students were able to start various types of aircraft engines, interact with multiple aircraft systems training aides, take flights in the flight simulator as well as fly a special drone around an obstacle course. Students had an engaging and enriching experience and were excited to participate in this event.

Employer Partners

The Center has many employment partners who are pleased with the rigorous training that ACE students receive. Airbus, PSA Airlines, ST Engineering, Gulfstream and Crestview Aerospace have made visits to the Center to provide insight into the aerospace industry and recruit prospective program completers. Students have taken tours of maintenance facilities at Lockheed Martin, Crestview Aerospace, and ST Engineering. Gulf Air is also expanding its site at the Bob Sikes airport and will be seeking 50+ jobs that ACE completers are prepared to fill. Additionally, Aerosource made a \$21,000 gift-in-kind donation of aircraft components and assemblies to the Center in February.

Aviation Program Advisory meetings have also taken place twice per year: one in the spring and one in the fall. The advisory board meetings are comprised of aviation, aerospace, business and industry leaders throughout the College's service territory. Through these meetings, the College receives valuable feedback on our training programs and is made aware of the latest industry trends and needs.

Annual Report of Project Progress Fiscal Year 21/22

The program has enrolled a total of 26 new students this fiscal year with due mostly to the participant recruiter's effort. She has been able to maintain partnerships with the graduation coaches at each high school in order to work with student who need smaller class sizes and are interested in a construction field. She has also identified Churches in the community who are excited to refer participants to the Youth Build Program. The Participant recruiter is 100% dedicated to identifying and engaging students who are interested in construction classes and achieving their certifications.

The lower enrollment is due to staff turn over in key roles and tougher restriction to entering the program through Youth Build. The program is currently looking for a Executive Director, Career Coordinator and GED Instructor. We have formed a partnership with Pensacola State College to provide a part time GED instructor at our campus.

This year the Students have earned a total of 24 OSHA/ 7 NCCER Core and NCCER Carpentry 0 Certification totaling 31 of the 130 Certs allowable in our metrics. It has been determined that lower numbers and transportation issues has been a barrier for identifying students who will be able to attend school regularly.

It is expected that the certifications will increase once we identify staff. We have continued our partnership with Escambia Counties Block by Block to have all of our participants learn through a build project that will also give back to the community. The students are currently work with the county to update a house across from Brownsville Community Center.

Dear Chairman Bear.

We are pleased to submit the Panama City Port Authority's quarterly report on grant project No. 227 to the Triumph Gulf Coast Board of Directors.

Triumph awarded the Panama City Port Authority a \$3,000,000 grant on October 7th, 2020, with the Port Authority providing \$1,500,000 for the local match. This strategic investment will enable the port to further expand the Intermodal Distribution Center (IDC), centrally located less than thirty minutes inland from the Port's East and West Terminals. The IDC is located along US Highway 231 and the Bay Line Railroad, which are the main road and rail freight corridors connecting Panama City to Interstate 10 and Interstate 65, along with the CSX and NS rail networks. Once completed, the expanded shovel-ready sites and connectivity to port, rail, and highway networks will enable the Port Authority to continue work with local and regional economic development agencies to attract new industries to Northwest Florida. As part of this project, Commerce Boulevard is being extended by the City of Panama City to provide access for the new FedEx Ground distribution center.

The Port Authority's site contractor, ECSC, commenced site work construction on April 5th, 2022. Work has progressed steadily on the fifty-three acre project. The contractors have been focusing on excavating the two, new stormwater ponds and removal of unsuitable soils. Based on the current schedule and weather conditions, the project is estimated to complete in the fourth quarter of 2022.



To date, project expenses total \$1,033,793.25 in construction and engineering management fees. When the project is completed, there will be approximately seventy-four acres (which includes the fifty-three acres being improved as part of the Triumph grant project #227) that will be shovel-ready for development.

The new FedEx Ground facility construction is progressing and is scheduled to be completed early in the fourth quarter of 2022. When completed, the square 251,000 foot facility will serve as a regional distribution center for FedEx. The 33-acre site was chosen, in part, due to its certification through the Gulf Power Certified



Site Program, ease of access to major highways, proximity to customers' distribution centers, and a strong local community workforce for recruiting employees. The \$55 million project will support two-hundred jobs as the facility is fully developed and operational. To celebrate the construction of the new FedEx facility, the Bay EDA in partnership with the Port held a successful groundbreaking ceremony on April 21st, 2022.



The Port looks forward to continued progress of construction in the third quarter of the site project. We value our partnership with Triumph Gulf Coast, and look forward to successful completion in 2022.

Building Renovation and Equipment

On March 1, 2022, the School Board of Walton County approved Construction Management at Risk firms for Continuing Services for Minor Projects. On March 15, 2022, the School Board of Walton County approved the Architectural Professional Service Agreements for Continuing Services for Minor Projects. WCSD will utilize qualified firms selected through this selection process for the design and construction of the Magnet Innovation Center and Emerald Coast Technical College building remodel/renovations. On April 9, 2022, the WCSB approved the task order assignment list for Construction Managers and Architect firms. DAG Architects was selected as the Architect and Childers Construction was selected as the Construction Manager for the Emerald Coast Technical College/ DFS campus building remodel/renovations. Florida Architects was selected as the Architect and Allstate Construction was selected as the Construction Manager for the Magnet Innovation/Emerald Coast Technical College building remodel/renovations. On April 6, 2022 a stakeholder meeting was held for the design of the ECTC space at the Magnet Innovation Center. On July 17, 2022 a stakeholder meeting was held for the design of the Mock Emergency Room. The proposed design will be for 6,000 SF of instructional space for a mock emergency medical response training facility. On July 19, 2022, the School Board of Walton County approved the task order to DAG Architects for architecture and engineering services to provide design, construction documentation, and construction administration services in the amount of \$179,716.00. Florida Architects is in the process of the design for the Magnet Innovation/Emerald Coast Technical College building remodel/renovations. DAG Architects is in the process for the design of the Emerald Coast Technical College/ DFS campus building remodel/renovations.

Supplies and Materials Cert Prep

Walton County School District agreed to provide \$63,500 in supplies and materials/cert prep for the total grant period. In year one, Walton County School District agreed to provide \$14,000 for supplies and materials/cert prep during the 2021 calendar year. A list of industry certifications earned is attached to the #230 Smartsheet. The total certs earned for August 1, 2021- October 31, 2022 is 547 industry certs, of which 7 industry certifications were earned from June 30, 2022- October 31, 2022.

Tuition Waivers/Supports & Accred. Fees

Triumph agreed to reimburse \$168,500 to the Walton County School District for tuition waivers/supports & accreditation fees for the total grant period. In year one, Triumph agreed to provide \$3,500 for tuition waivers/supports & accreditation fees during the 2021 calendar year. Walton County School District will request reimbursement in the amount of \$2,250 for accreditation fees and \$1,013.25 for tuition waivers.

At this time the Okaloosa County School District has completed renovations to all AI classrooms except Crestview High School. Crestview High School's renovations will begin in Spring 2023 with the program starting in the Fall 2023.

Current enrollment is 304 students in 8 middle schools and 1 high school. Students will take the Knowledge Pillars Python Coding Specialist (PCS) certification exam at the end of the school year. With an expected pass rate of 50% (152 students) of our enrollment, this will exceed the predicted number of certifications of 50 for the first year.

The AMPD (AI) Advisory Board has been created and will begin meeting quarterly in January 2023. The board is comprised of industry partners, AFRL employees, University of Florida consultants, and school district personnel. An introductory meeting was held in September to discuss the purpose of the board and to finalize a meeting schedule.

We continue to work with Dr. Nancy Ruzycki, University of Florida Instructional Associate Professor, and her team to develop curriculum and student performance standards for the 4-year track which includes programming, data science, machine learning and a capstone project. We meet biweekly, Curriculum frameworks for the program have been submitted (June 2022) to the Florida Department of Education. We expect approval in November.

Professional development is ongoing. Teachers met in March, April, May, June, July, and October to discuss pacing, curriculum, student performance standards, lesson plans, quarterly projects, and certifications. A Canvas sandbox was created for teachers to share lessons. Jared Carter, UF Consultant facilitates the meetings and the Canvas sandbox. Future meetings are scheduled for January, March, and May 2023.

B. Project Summary

1. **Progress of Project** – ASCENT has been aggressively working outreach initiatives within all three areas identified within the grant application: K-12, College/University, as well as Community Initiatives. While the primary focus initially began with initiatives focused specifically within Bay County, efforts have now expanded to include Okaloosa, Walton, Franklin counties. Outreach efforts continue to the remaining counties.

Larger accomplishments include Teaching Technology Together (T3) Academy which resulted in five weeks of intensive training in Python, HTML, CSS, WordPress and Adobe. A total of 23 teachers were involved in the initial training summer of 22. Cohort 2 of T3 Academy begins summer of 2023 and includes iCampPC leadership development for students participating in integrated technology clubs as well as showcase scheduled for March 23. T3 training now expanding to surrounding counties. From the T3 Academy we developed the Integrated Technology Clubs (ITC), as well as received grant funds in support if ITC in Bay and Walton.





In accordance with 288.8016, F.S. Pensacola-Escambia County Promotion and Development Commission (PEDC) as grantee, is providing this annual report for #259 PEDC-Project PIONEER. A grant agreement was executed on February 11, 2022, providing for \$2,500,000 in Triumph grant funds utilized to partially fund PEDC's purchase of property located at 9101 Ely Road, Pensacola, Escambia County, Florida. Further, the grant completion deadline (grant end date) is December 31, 2025.

We are pleased to report that the project is progressing according to schedule:

- Acquisition of the 172,000 SF manufacturing facility was completed on March 28, 2022, and the project is currently in pre-construction phase.
- Selection for Design/Engineering contractors for building modification and conversion of the facility to accommodate pharmaceutical manufacturing is underway. Conceptual design and plans will be finalized in December 2022.
- Renovation of the production space is expected to begin January 2023 through January 2024 with FDA approvals/validation process to subsequently commence afterward.
- The office spaces, training rooms and meeting rooms updates are taking place and have primarily entailed partial repainting and new carpet installation to date.
- Once office renovations are completed, these match funds expenditures will be itemized and provided in the January 2023 quarterly progress report.

Metrics for the project include meeting the following criteria:

(a) performance commencement date to occur within three years after the date that renovations have been substantially completed as evidenced by a certificate of occupancy

(b) creation of 63 net new scientific and life-sciences manufacturing jobs that will pay an average of 136 percent greater than the Escambia average county wage of \$45,074 and will provide a complete fringe benefits package.

It is anticipated that the job creation commitment will be met by the end of the third year following completion of the building construction and improvements and that these jobs will then be maintained for at least three additional years.

Pegasus Laboratories Announce Major Expansion in Pensacola
