SECOND AMENDMENT TO

GRANT AWARD AGREEMENT

(Wakulla County School Board/Project #198)

THIS SECOND AMENDMENT TO GRANT AWARD AGREEMENT (this "Amendment") is made and entered into as of <u>January 19, 2023</u>, 2022X by and between TRIUMPH GULF COAST, INC., a Florida not-for-profit corporation ("Triumph"), and the "), and WAKULLA COUNTY SCHOOL BOARD ("WCSB").

WITNESSETH:

WHEREAS, Triumph and WCSB are parties to that certain Grant Award Agreement dated October 21, 2019, as amended by that certain First Amendment to Grant Award Agreement dated February 24, 2021 (as amended, the "Agreement"). All capitalized terms herein shall have the meanings set forth in the Agreement; and

WHEREAS, WCSB has requested that certain amendments be made to the Agreement, including, but not limited to, increasing the Grant by Three Hundred Thirty Thousand Dollars (\$330,000.00) and increasing the Matching Funds by Three Hundred Thirty Thousand Dollars (\$330,000.00); and

WHEREAS, Triumph is agreeable to certain amendments to the Agreement as described herein.

NOW, THEREFORE, in consideration of the mutual covenants, promises herein and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Triumph and WCSB hereby agree as follows:

- 1. Amendment to Section 2. Section 2 of the Agreement is hereby deleted and replaced in its entirety with the following:
 - "2. Grant Award. On and subject to the terms and conditions set forth herein, Triumph hereby agrees to make a grant to WCSB in the aggregate maximum amount of Two Million One Hundred Ten Thousand and 00/100 Dollars (\$2,110,000) (the "Grant") to provide partial funding for the Project."
- 2. Amendment to Section 4.1(a). Section 4.1(a) of the Agreement is hereby deleted and replaced in its entirety with the following:
 - "(a) "\$930,000 of the Grant funds shall be allocated for Salaries, to be funded in the amounts and at the times as set forth in the Budget;"
- 3. Amendment to Section 4.2(c). The first sentence of Section 4.2(c) of the Agreement is hereby amended to read in its entirety as follows:

- "(c) The amount requested for funding under the Request for Funding, together with all amounts previously funded under the Grant, would exceed the \$2,110,000 maximum amount of the Grant; or the amount requested for funding under the Request for Funding for a particular Budget category, together with all amounts previously funded for such Budget category, would exceed the maximum amount allocated to such Budget category; or WCSB failed to use any Grant funds funded to date in the amounts and for the purposes stated in the Budget;"
- 4. **Amendment to Section 5.2.** The first sentence of Section 5.2 of the Agreement is hereby amended to read in its entirety as follows:

"The total cost of the Project is \$2,767,135, of which (i) WCSB shall pay \$657,135 as shown in the Budget (collectively, the "Matching Funds"), and (ii) \$2,110,000 shall be provided by the Grant."

- 5. Amendment to Section 8.3(a). Section 8.3(a) of the Agreement are hereby amended to read in its entirety as follows:
 - "(a) Performance Metric #1: (i) By December 31, 2026, not less than 175 students will have obtained industry-recognized certificates in Visual Sight Operation (VSO) and not less than 175 students will have obtained industry-recognized certificates in Unmanned Aircraft Systems (UAS), and (ii) by June 30, 2027 100 certificates will be earned by middle schoolers that prepare them for higher level VSO and UAS certificates."
- 6. **Deletion of Certain Provisions**. Section 4.2(p) and Section 5.12 are hereby deleted in their entirety.
- 7. Amendment to Exhibits: The form of Application for Funding attached to the Agreement as Exhibit "A" is hereby deleted and replaced with the form of Request for Funding attached hereto as Exhibit "A" and incorporated herein, and all references in the Agreement to an Application for Disbursement shall hereafter mean and refer to a Request for Funding. The Budget/Timeline attached to the Agreement as Exhibit "B" is hereby deleted and replaced with the form of Budget attached hereto as Exhibit "B" and incorporated herein, and all references in the Agreement to the Budget shall hereafter mean and refer to the Budget attached hereto.
- 8. **No Other Amendments**. Except as expressly provided above, the Agreement shall remain unmodified and in full force and effect.

 - (b) This Request for Funding does not seek funding for items other than for the Budget category shown above;
 - (c) The amount requested, together with all amounts previously funded under the Grant, does not exceed the \$2,110,000 maximum amount of the Grant; the amount requested for the above-shown Budget category, together with all amounts previously funded for such budget category, does not exceed the maximum amount allocated to such Budget category; and WCSB has used all Grant funds released to date in the amounts and for the purposes stated in the Budget;
