Brief Description of Individual/Entity/Organization:

The Northwest Florida Beaches International Airport (ECP) opened in May of 2010 offering the Region new opportunities in air travel, as well as aerospace manufacturing and repair. Prior to the opening of the ECP Airport, PFN Airport served the City of Panama City and its surrounding communities with regional jet service to Atlanta. In May 2010, PFN closed and ECP opened in a new location with a 10,000-foot runway and additional property for development. The increased capacity at ECP's new location afforded the region the opportunity to add service with Southwest Airlines, United Airlines, American Airlines, and the up-gauging of Delta aircraft, thus becoming the first Main Line Station for Delta Airlines in the Panhandle. Since the opening, United Airlines has added service to Houston's George Bush Intercontinental Airport with connections to more than 160 cities worldwide and American Airlines to Charlotte, Dallas-Ft Worth, and Washington D.C. to more than 32 countries around the world. In addition to adding new service routes, ECP has continued to surpass expectations for passenger traffic. In 2009, PFN's record year, the airport saw approximately 312,000 total passengers. In 2022, the annual passenger traffic for ECP reached nearly 1.6M.

ECP continues to be in the spotlight of site consultants due to its physical assets, close proximity to the beach, 4-lane highway system, and quick and easy access to the global air traffic network.

Location: Bay County, Florida

Project estimated investment: \$500,000,000

Job Creation: 1,800 by end of 2030, with average salary estimated at \$100,000 which is more that 115%

of the average wage in Bay County.

The aviation industry is a key target market for recruitment in Bay County, Florida. Project Stamper will be an excellent asset to the region and will complement the accelerated growth at the ECP airport. Project Stamper is an advanced manufacturing company that will create 1,800 new jobs in Bay County and will infuse more than \$500M into our community. The company plans to construct a 600,000 square foot manufacturing facility adjacent to the ECP 10,000ft runway. This operation will be a full-service advanced manufacturing facility. In addition, it is expected that the Florida Panhandle region will experience further growth as the supporting supply chain network will look to accompany the OEM in the region. Due to the magnitude of this project, Project Stamper will be a transformational project for the entire Florida Panhandle, as it will provide opportunities for residents and communities throughout the region.

Furthermore, the company plans to work closely with the existing FAA approved A & P aviation mechanics programs at Haney Technical College and Northwest Florida State College to provide local opportunities for graduates of the program. The company also plans to leverage existing assets at Gulf Coast State College and Florida State University to train future personnel, providing skills and opportunity for successful careers in advanced manufacturing.

Working with the Airport Authority, Bay County Commission and Space Florida, the Triumph funds will be used for site infrastructure improvement and facility construction costs.

There are numerous factors that make the Bay County area favorable for Project Stamper operations:

- ECP is the newest airport in the United States
- The site is adjacent to a 10k ft runway and is "shovel ready".
- There are no OEM operations in Bay County.
- Most jobs are in the service and hospitality industry and are seasonal.
- Gulf Coast State College, along with Haney Technical College will facilitate tailored training Courses for all employees.

- Career Source Gulf Coast has agreed to assist in advertising open positions & source candidates.
- Military bases in the areas also offer additional opportunities to create programs to hire veterans.
- In addition, this project will complement the growth at our airport where we had approximately 1.6M passengers in 2022.
