Project Stamper is an aviation Original Equipment Manufacturer (OEM) that manufactures electric aircraft. The company, headquartered in California, desires to expand to Florida because of its proximity to key customers, low tax, and business-friendly environment.

Initially, the company was considering numerous sites across the United States. The original project parameters projected the creation of 1800 jobs with an average wage of \$100k and an estimated capital investment to be \$500M. The company has since refined the project scope, based on a specified location at Northwest Florida Beaches International Airport (ECP), and the new project metrics are as follows: 1800 jobs with an average wage of \$68,705 and a capital investment of \$407.5M.
