Ms. Henderson:

As per your request, the changes have been made in this application letter to update your request. Please note that the final breakout you requested is in the chart that was in this document as Attachment G, but for the purpose of highlighting that number, it is also in the bullet below:

- The final amount requested for the grant is \$7,454,867.00.
- The number of earned certifications over the four-year term of this grant is 3,479.
- The number of projected certifications for CTE enrolled students was adjusted by 50% to acknowledge a start in funding that would only apply to the upcoming year (2024), with full year projections of certifications beginning in 2025 and continuing into 2033, as noted in the adjusted Attachment G on page 11 of the application. The projections assume that each enrolled student in the CTE program would earn 2 CTE certifications each year, with an expectation of over 10,000 certifications earned over ten years by 2033. See **Attachment G** below.
- The Parent University costs that are factored into the Personnel category are estimates of salary/stipends for teachers who will be *providing only CTE-related content that is approved by Triumph, from both the funding and matching funds perspective.* This CTE-related content will be delivered to parents/guardians of enrolled students who would be attending after school sessions, Saturday sessions, and sessions that would be scheduled during the summer or during extended holiday periods.
- The contract for third-party oversight of the grant process by EduSolve has been significantly reduced in order to accommodate the fiscal needs of the school in other areas that are of high priority.
- Matching funds details are contained in the Budget Template SS being sent to you as a separate attachment to this letter in an email.





Thanks again for your review, and we hope that we have met the deadlines for this information in order to have our application presented at the November 6 meeting.
