#### (iii) Location of the project or program;

The Coastal Resilience Training Center is located at 60 Island Drive in Eastpoint (Franklin County), Florida. The 22,000 square foot facility features computer training labs, classrooms, a 200 seat community training room, NCCER certified workshop, high school program and administrative offices. The facility is located adjacent to the Apalachicola National Estuarine Research Reserve. The program serves youth ages 16-27 from communities spanning all disproportionately affected counties from Wakulla to Escambia.

#### (iv) Description of the proposed program, including how the program will be transformational and promote economic recovery, diversification, and enhancement of the disproportionately affected counties.

The Coastal Resilience Training Center (CRTC) serves as the home base for Franklin's Promise Coalition, housing the youth conservation corps programs provided by the Conservation Corps of the Forgotten and Emerald Coasts, ED Corps and OysterCorps.

Founded in 2002, Franklin's Promise Coalition (FPC) is highly valued by and broadly entrenched in the communities served. FPC was seeded to host conservation corps programs in 2015 by the Nature Conservancy, The Corps Network and the National Fish and Wildlife Foundation as part of the Gulf Coast Restoration Initiative, establishing the Conservation Corps of the Forgotten and Emerald Coasts (CCFEC) to restore the region's natural habitats and enhance the economy through workforce education. The initiative now has crews who work in Franklin, Gulf, Bay, Wakulla, Okaloosa, Walton, Santa Rosa and Escambia Counties. FPC has participated in a regional capacity building program, GulfCorps, from its creation, the coalition now hosts the largest number of crews in the network. To date, FPC has completed 4,231 acres of restoration work and 192,000 hours of crew member service. FPC has leveraged over \$925,367 in Fee for Service funding and \$2,959,273 in AmeriCorps funding to complement the GulfCorps resources.

Now in its 9th year, CCFEC has a history of completing significant environmental restoration projects, placing members on career pathways, responding to disasters, and meeting critical community needs. CCFEC has employed, trained and provided service opportunities to over 460 young adults. They have earned over 1800 industry certifications, completed over 360 conservation and construction projects, as well as responded to 9 regional disasters including the pandemic.

In August 2016, ED Corps High School began as the academic component of the Conservation Corps with the mission of providing an opportunity for members to complete their high school diplomas. The program served as the official alternative school of the Franklin County School District from 2016 to 2020. In the Fall of 2020, ED Corps High School was established as an independent private school and is now based out of the Coastal Resilience Training Center in Eastpoint, Florida, serving students 16 years old and up. The focus is to support vulnerable students to complete high school, graduate on time, and if they desire, to join the Conservation Corps as a career training program. ED Corps High School has graduated 42 members to date.

The career training program offered at the CRTC is based on the 8-year history and success of the RESTORE Act funded grant, GulfCorps, which is administered by the National Oceanic and Atmospheric Administration (NOAA) and managed by The Nature Conservancy (TNC). As one of GulfCorps' largest participating corps organizations (operating five crew locations in Florida), CCFEC crews are local youth ages 18 to 25 (veterans up to age 27) who live in underserved/marginalized communities. All members qualify for the Opportunity Youth Service Initiative (OYSI) AmeriCorps program, requiring members to be low income participants who are suffering one or more barriers to career sustainability. Launched in 2013 through an AmeriCorps grant from the Corporation for National and Community Service, the Opportunity Youth Service Initiative (OYSI) is designed to provide education, training, and conservation service experience to underserved young people experiencing barriers (e.g. poverty, unemployment, education, past court involvement, incarcerated parents, physical or learning disability). During their term of service, OYSI members develop job skills, earn certifications, complete their high school requirements, and receive assistance in transitioning to postsecondary education or the workforce. Members receive weekly living allowances and upon completion of their term of service, they receive a Segal AmeriCorps Education Award for future education/training advancement (up to \$12,000). No less than 80% of members struggle with at least one of the barriers mentioned above. The proposed project will provide training to no less than 800 members with each earning a minimum of 4 certifications per year.. The communities will benefit from the economic impact of crew members' weekly stipends and staff wages totaling over \$14,000,000.

The Coalition will continue to build upon existing project agreements in place with over 40 land management partners spanning the panhandle including Franklin, Gulf, Santa Rosa, and Escambia counties. Hands-on field project training is supported by regional and state agencies such as the Northwest Florida Water Management District, Apalachee Regional Planning Council, Florida Forest Service, Florida Fish and Wildlife Commision, Florida State Parks, and Florida Department of Environmental Protection.

Crew members will receive training and certifications in transferable job skills and 6 different career pathways outlined below:

### (v) Summary timeline for the proposed project or program.

The project is proposed for a 10 year period beginning with completion of an executed agreement.

Phase 1- Which could begin January 1, 2024 would last for two years, providing for the engagement of 140 members who earn no less than 420 certifications. Training would implement existing curriculum while expanding certifications to build out the transferable job skills and career pathways. Phase 1 would initiate curriculum development and facilitate training partner relationships to enhance course offerings in Phases 2 and 3.

Phase 2 - will include years 3 through 5, focusing on implementing the proposal for 310 members who complete no less than 1,040 certifications. Through adaptive management, member engagement and partner input the program will be modified as appropriate. Phase 2 will include the development of a 5 year sustainability plan.

Phase 3 - will include years 6 through 10, focusing on implementing the proposal for 850 members who complete no less than 2,400 certifications.

Total members engaged 1,300, total certifications completed 3,860 at a value of \$2,623.85 each.
