FOURTH AMENDMENT TO GRANT AWARD AGREEMENT (Wakulla County School Board/Project #198)

WHEREAS, WCSB has requested that certain amendments be made to the Agreement; and

WHEREAS, Triumph is agreeable to certain amendments to the Agreement as described herein.

NOW, THEREFORE, in consideration of the mutual covenants, promises herein and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Triumph and WCSB hereby agree as follows:

1. **Amendment to Section 8.3(a)**. Section 8.3(a) of the Agreement is hereby amended to read in its entirety as follows:

"(a) **Performance Metric #1**: By June 30, 2027, high schoolers and middle schoolers combined will have obtained 450 industryrecognized certificates in either Unmanned Aircraft Systems (UAS) or in Visual Sight Operation (VSO)."

2. **Amendment to Budget:** The Budget attached as Exhibit "B" to the Agreement is hereby deleted and replaced with the Budget attached hereto as Exhibit "B" and incorporated herein. All references to the Budget in the Agreement shall hereafter mean and refer to the Budget attached hereto as Exhibit "B."

3. **No Other Amendments**. Except as expressly provided above, the Agreement shall remain unmodified and in full force and effect.
