

SECOND AMENDMENT TO
GRANT AWARD AGREEMENT
(Wakulla County School District, Florida/Project #29)

THIS SECOND AMENDMENT TO GRANT AWARD AGREEMENT (this “**Amendment**”) is made and entered into effective as of the Effective Date (as defined on the signature page below), by and between TRIUMPH GULF COAST, INC., a Florida not-for-profit corporation (“**Triumph**”), and the WAKULLA COUNTY SCHOOL BOARD, a political subdivision of the State of Florida (“**WCSB**”).

WITNESSETH:

WHEREAS, Triumph and WCSB are parties to that certain Grant Award Agreement dated July 23, 2018, as amended by that certain First Amendment to Grant Award Agreement dated January 28, 2020 (as amended, the “**Agreement**”). All capitalized terms herein shall have the meanings set forth in the Agreement; and

WHEREAS, WCSB has requested that certain amendments be made to the Agreement; and

WHEREAS, Triumph is agreeable to certain amendments to the Agreement as described herein.

NOW, THEREFORE, in consideration of the mutual covenants, promises herein and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Triumph and WCSB hereby agree as follows:

1. **Amendment to Section 7.3.** Paragraphs 1, 2 and 3 of Section 7.3 of the Agreement are hereby amended to read in their entirety as follows:

“**1. Performance Metric #1:** For the 2023-2024 school year, there shall have been issued at least 300 certifications in K-5 digital tools, 50 certifications in grades 6 - 8 digital tools, 30 certifications in HVAC, and 30 certifications in Automotive.

2. Performance Metric #2: Between the beginning of the 2020-2021 school year and the end of the 2023-2024 school year, in the aggregate at least seventy percent (70%) of those enrolled in the K-5 digital tools, grades 6 - 8 digital tools, HVAC, and Automotive certification program actually complete the program and obtain a certificate.

3. Performance Metric #3: Intentionally Omitted.”

2. **No Other Amendments.** Except as expressly provided above, the Agreement shall remain unmodified and in full force and effect.
