

SECOND AMENDMENT TO
GRANT AWARD AGREEMENT
(FSU - Apalachicola Bay System Initiative/Project #69)

THIS SECOND AMENDMENT TO GRANT AWARD AGREEMENT (this “**Amendment**”) is made and entered into effective as of the Effective Date (as defined on the signature page below), by and between TRIUMPH GULF COAST, INC., a Florida not-for-profit corporation (“**Triumph**”), and FLORIDA STATE UNIVERSITY (“**FSU**”).

WITNESSETH:

WHEREAS, Triumph and FSU are parties to that certain Grant Award Agreement dated March 15, 2019, as amended by that certain First Amendment to Grant Award Agreement dated June 2019 (as amended, the “**Agreement**”). All capitalized terms herein shall have the meanings set forth in the Agreement; and

WHEREAS, FSU has requested that certain amendments be made to the Agreement; and

WHEREAS, Triumph is agreeable to certain amendments to the Agreement as described herein.

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations herein and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties agree as follows:

1. Amendment to Section 4.1. Section 4.1 of the Agreement is hereby deleted and replaced in its entirety with the following:

4.1 General Allocation of Grant in Budget Categories. The Grant shall be allocated as more fully shown in the Budget attached hereto as **Exhibit “B”** and incorporated herein (the “**Budget**”).

2. Amendment to Section 5.1. The “Completion Deadline” described in Section 5.1 of the Agreement is hereby changed to December 31, 2025.

3. Amendment to Budget. The Budget attached as Exhibit “B” to the Agreement is hereby deleted and replaced with the Budget attached hereto as Exhibit “B” and incorporated herein. All references to the Budget in the Agreement shall hereafter mean and refer to the Budget attached hereto as Exhibit “B.”

4. No Other Amendments. Except as expressly provided above, the Agreement shall remain unmodified and in full force and effect.
