

FIRST AMENDMENT TO  
GRANT AWARD AGREEMENT  
(Wakulla County, Florida /Project Safety/Project #345)

THIS FIRST AMENDMENT TO GRANT AWARD AGREEMENT (this “**Amendment**”) is made and entered into as of the Effective Date (as defined below), by and between TRIUMPH GULF COAST, INC., a Florida not-for-profit corporation (“**Triumph**”), and WAKULLA COUNTY, FLORIDA ACTING THROUGH ITS BOARD OF COUNTY COMMISSIONERS (“**Grantee**”).

WITNESSETH:

WHEREAS, Triumph and Grantee are parties to that certain Grant Award Agreement dated August 8, 2025, (the “**Agreement**”). All capitalized terms herein shall have the meanings set forth in the Agreement; and

WHEREAS, Grantee has requested that certain amendments be made to the Agreement; and

WHEREAS, Triumph is agreeable to certain amendments to the Agreement as described herein.

NOW, THEREFORE, in consideration of the mutual covenants, promises herein and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Triumph and Grantee hereby agree as follows:

1. **Amendment to Budget.** The Budget attached as Exhibit “B” to the Agreement is hereby deleted and replaced with the Budget attached hereto as Exhibit “B” and incorporated herein. All references to the Budget in the Agreement shall hereafter mean and refer to the Budget attached hereto as Exhibit “B.”
2. **Amendment to Section 5.1.** The “Construction Completion Deadline” as defined in Section 5.1 of the Agreement is hereby extended and shall hereafter mean and refer to December 31, 2027.
3. **Amendment to Section 8.3(a)(ii).** The date listed in Section 8.3, subparagraph (a)(ii) of the Agreement is hereby extended from December 31, 2032, to December 31, 2033.
4. **No Other Amendments.** Except as expressly provided above, the Agreement shall remain unmodified and in full force and effect.
